

**Amendment No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND VICTOR TREATMENT CENTERS FOR SPECIALTY MENTAL
HEALTH SERVICES FOR FISCAL YEAR 2023-24**

This 1st Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Victor Treatment Centers, INC., hereinafter referred to as “Contractor,” collectively referred to as the “Parties.”

RECITALS

WHEREAS, the County entered into an Agreement with Contractor effective June 1, 2023; and
