

**Amendment No. 3 to the AGREEMENT BETWEEN THE COUNTY OF  
LAKE AND VISTA PACIFICA ENTERPRISES, INC. FOR ADULT  
RESIDENTIAL SUPPORT SERVICES AND SPECIALTY MENTAL  
HEALTH SERVICES FOR FISCAL YEAR 2023-24**

**This Amendment No. 3 to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Vista Pacifica Enterprises, INC. hereinafter referred to as “Contractor,” collectively referred to as the “parties.”**

**RECITALS**

**WHEREAS**, the County entered into an Agreement with Contractor effective July 1, 2023, and;

**WHEREAS**, utilization of services provided by Contractor exceeded projections, and;

**WHEREAS**, the parties amended the Agreement to increase the total compensation payable by \$100,000.00 for a new contract maximum of \$300,000.00 on March 27<sup>th</sup>, 2024; and

**WHEREAS**, the parties amended the Agreement a second time on June 21<sup>st</sup> 2024 to increase the total compensation payable under the Agreement by \$100,000.00 for a new contract maximum of \$400,000.00 and must amend item three, “Compensation,” to reflect this change.

**WHEREAS**, the parties now desire to amend the Agreement a third time to increase the total compensation payable under the Agreement by \$14,300.00 for a new contract maximum of \$414,300.00 and must amend item three, “Compensation,” to reflect this change.

**NOW THEREFORE**, based on the foregoing recitals, the parties hereto agree as follows:

**3.     COMPENSATION.** Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, “**Scope of Services.**” **Compensation to Contractor shall not exceed Four Hundred, Fourteen Thousand and Three Dollars (\$414,300.00).**

The County shall compensate Contractor for services rendered, in accordance with the provisions set forth in **Exhibit B**, titled, “**Fiscal Provisions,**” attached hereto and incorporated herein, provided that Contractor is not in default under any provisions of this Agreement. Compensation to Contractor is contingent upon appropriation of federal, state and county funds.
