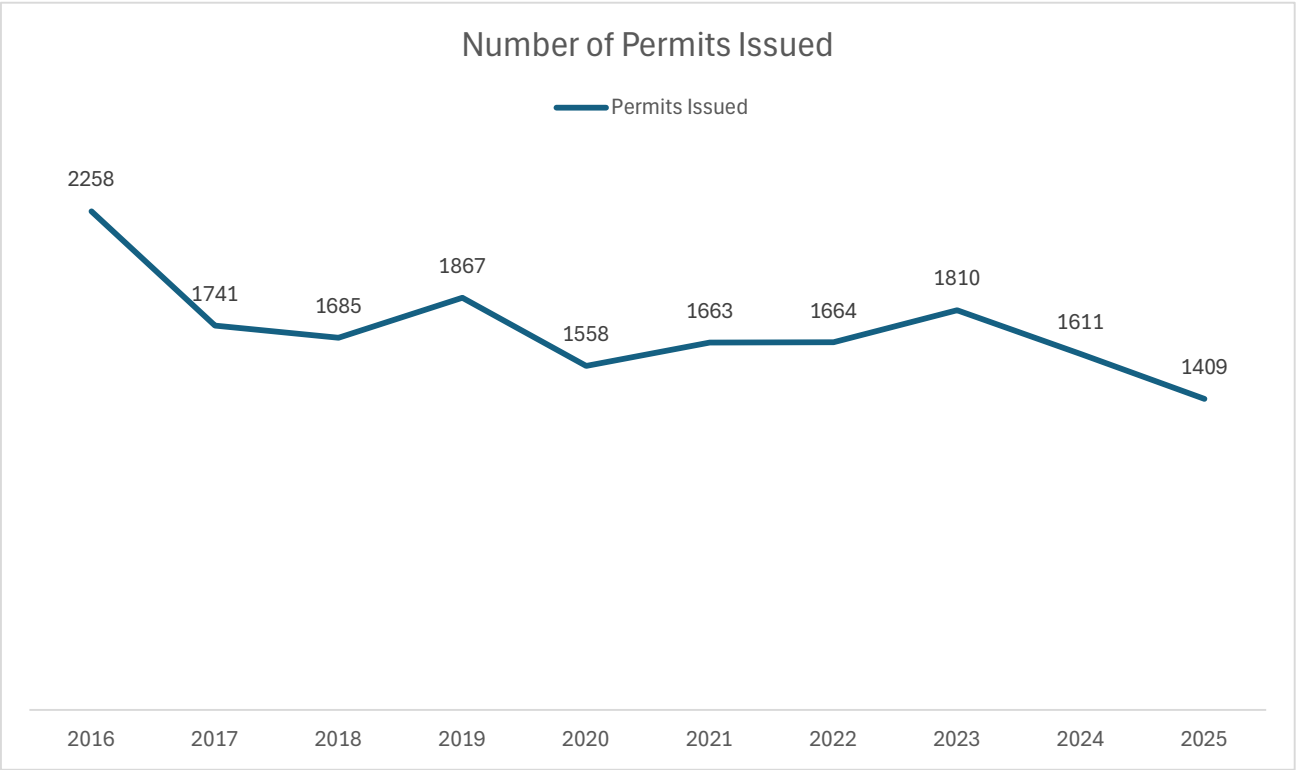

Other:

California's housing starts jumped in the first quarter of 2025 amid the post-election bounce in homebuilder sentiment, then weakened after April's tariff hike shock. Single-family construction is forecast to edge lower again in 2026, while multifamily housing is forecast to hold steady.

CoAmerica - 2026 California Annual State Economic Outlook

Overall, the forecast saw California's economy growing more slowly than the nation's this year (2025), "with several quarters of negative job growth." A bounce back could start next year, and economic growth is expected to increase in 2027.

Sacramento Bee, June 2025

Nickelsburg predicted the state economy would begin a recovery in late 2026, with economic growth picking up more steam in 2027. Once the state is past the current weakness, which is expected to occur in late 2026, a tech, durable goods manufacturing and construction resurgence should lead to California's superior growth once again, according to the UCLA forecast.
