

**AMENDMENT No. 3 to the AGREEMENT BETWEEN COUNTY OF LAKE
AND WILLOW GLEN CARE CENTER FOR ADULT RESIDENTIAL
SUPPORT SERVICES AND SPECIALTY MENTAL HEALTH SERVICES
FOR FISCAL YEARS 2022-23, 2023-24, and 2024-25**

This Third Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Willow Glen Care Center, hereinafter referred to as “Contractor,” collectively referred to as the “parties.”

RECITALS

WHEREAS, the County entered into an Agreement with Contractor effective July 1, 2022; and

WHEREAS, the parties amended the Agreement to decrease the total compensation payable by \$100,000.00 for a new contract maximum of \$885,500.00 on May 11, 2023; and

WHEREAS, the parties amended a second time to correct the termination date of the Agreement, which erroneously stated a date of June 30, 2023 when it should have been June 30, 2025; and

WHEREAS, the parties now desire to amend the Agreement a third time to update rates for the 2023-24 fiscal year, in **Exhibit B**, “Fiscal Provisions,” item 4.1.

NOW, THEREFORE, based on the forgoing recitals, the parties hereto agree as follows:

Section 4.1 of EXHIBIT B – “Fiscal Provisions” is hereby amended to state as follows:


