WITNESSETH:

WHEREAS, the COUNTY has entered into a General Services Agreement dated May 21, 2024 with CONSULTANT to perform services in support of professional architecture and engineering consulting services; and,

WHEREAS, the COUNTY and CONSULTANT now desire to also enter into this Supplemental Agreement with the scope of services described herein for architectural services related to the Structural Upgrade and Renovation of Lake County EOC / OES building.

NOW, THEREFORE, IN CONSIDERATION OF the covenants and agreements herein set forth, it is hereby agreed:

1. The General Services Agreement remains in full force and effect, and in the performance of this Supplemental Agreement CONSULTANT is held to all provisions and the terms of the General Services Agreement.

2. PROJECTS

The projects covered by this Supplemental Agreement shall include the following:

Architectural services related to Structural Upgrades and Renovation of the Lake County
EOC/OES building.

3. SCOPE OF WORK

The scope of work covered by this Agreement is described in the Scope of Work and Cost Proposal prepared by CONSULTANT for each facility, which is attached as Exhibit "A".

4. COMPENSATION

As full compensation for all work or services to be provided by CONSULTANT hereunder, County shall make payments to CONSULTANT based on monthly invoices for all services performed under this Agreement. Invoices shall reference the project title and include a detailed breakdown of work items completed to date and the cost of work remaining. Invoices shall be separate for each facility. Payment will be based on time and materials. Invoices are due and payable upon receipt. The total fee for the project will not exceed \$127,956.00, as allocated by building in Exhibit "A", without prior approval of the County. Upon satisfactory completion of services summarized in Exhibit "A", the final payment of any balance will be due upon receipt of the final invoice. The final invoice shall be submitted within 60-calendar days after completion of the CONSULTANT's work.

5. TERM

CONSULTANT shall begin immediately on the work as assigned and this AGREEMENT shall remain in full force for a period of two (2) years from the date of approval or until terminated by either party.

STRATA a | p will prepare the required construction documentation for approval by the AHJ. STRATA a | p will also perform construction administration and quality assurance services as required by the County through project completion.

The Project consists of providing bid documentation (plans and specifications) to identify the complete scope of the structural upgrade to bring the building in compliance with Essential Service building code requirements. New electrical/lighting/fire alarm and mechanical/plumbing systems are planned as part of the interior renovation. Coordination of county requirements for all low voltage for data communications is also included in the base project design scope. Documentation requirements will reflect county Standards. The service outline is noted below.

STRATAap proposes to provide the following Architectural services:

Scope of Services -

- Meetings with County staff if required and Sherriff to determine program.
- Field observation of existing conditions.
- Review recommendations with County & Sherriff.
- Preparation of construction documents.
- Provide 3rd party construction cost estimate.
- Construction Administration during the construction of the project and project closeout.
- Meetings, as necessary.
- Produce final record drawings from contractor as-builts.

Design Fee: \$127,956.00

If further services are requested by the County and agreed upon, additional services will be charged based on the attached 2024 rate sheet. If you find that this proposal is acceptable Strata AP is prepared to enter into a formal District agreement for professional services.

Exclusions:

- Hazardous materials identification and abatement. Does not include materials testing or hazardous material
 assessment.
- 2. Travel expenses are included in the proposal.
- 3. Civil Engineering.
- 4. Fire Protection design. If the Building department requires fire protection other than fire alarm an add service request will be provided to the County for review and approval.
- Reproduction expenses are not included in this proposal. To be billed as identified on the attached 2024 rate sheet.
- 6. Accessibility improvements. Accessibility improvements must be made to meet the requirements of Article 11B-202.4 of the California Building Code. For projects below the current threshold of \$200,000, there is a 20% additional spending requirement to comply with the current building code. There is no specific \$\$ limit for projects of greater value than \$200,000. This project will exceed the threshold, as such a plan for accessibility measures would need to be determined. This may include, path of travel, building entrances, restrooms, drinking fountains and parking, and may require additional design and engineering services to identify possible areas to address access compliance if PRMD enforces full code conformance. For the purposes of this proposal the 20% requirement is accounted for. A separate proposal will be provided depending on the level of compliance PRMD requests up and above the 20% compliance requirement.

Considerations:

The project consists of design for lateral strengthening of the Lake County Training Center to meet current Code for a Risk Category IV building. The existing structure is a manufactured metal building with a lateral force resisting system consisting of steel moment frames and diagonal rod cross bracing at the roof. Design for two schematic strengthening options will be provided for use in obtaining rough order of magnitude (ROM) cost estimates to be prepared by Others: 1) interior shear wall/braced frames; and 2) exterior diagonal steel buttresses. Some interior foundations may be required to meet lateral load resistiveness. Calculations performed for the schematic strengthening options will be used in the preparation of construction document level calculations should the project move forward.



Foundation plans and design loads from original construction drawings by Winzler & Kelly dated 2/28/92 are assumed to be as-built documents and will be used in the structural evaluation for lateral strengthening. Field investigation will be performed by the design to document the existing structural framing elements required for the lateral strengthening/analysis. The Owner will need to provide for the removal of finishes/ceiling and provide ladders/scissor lifts as necessary for the design team to field measure and document this existing structural framing. We anticipate the destructive testing to be invasive.
