### **Project Overview**

The Economic Mobility Leadership Network (EMLN) is a NACo cohort of county leaders that examines the range of complicated issues that comprise <u>economic mobility</u>, including housing, job creation, food insecurity and an overall lack of opportunity. With the EMLN, NACo county leaders build capacity to identify and assess their current barriers to opportunity and share scalable and transferable programs with peers across the country. The EMLN is structured around a model of in-person convenings in which members participate in interactive, on-site and multi-day convenings in diverse counties across the country.

NACo is seeking new members for the EMLN to join the cohort starting in Spring 2022.

#### Commitment

Participants should have the capacity to participate in monthly one-hour virtual cohort calls and 3 inperson convenings per year. The convenings will vary in geographic location but are typically located in an EMLN member county.

New members that are accepted will be invited to participate in the first in-person convening of 2022 in Mercer County, W.Va. on April 24-27, 2022.
