**DECLARATION OF CUSTODIAN OF
RECORDS**

10 I, the undersigned, being the duly authorized custodian of records or other qualified witness in the
11 employ of the Department of Cannabis Control declare as follows:

- 13 1. I am a custodian of records for the California Department of Cannabis Control. My business

26 0000296, and CCL21-0000297.
- 27 5. Licenses CCL21-0000294, CCL21-0000295, CCL21-0000296 were converted to CCL21-
28 0000293 on 07/06/2023 and CCL21-0000293 was converted to an Annual Adult-Use Medium,

Outdoor Cultivation license. License CCL21-0000293 expired 07/07/2024.

6. License CCL20-0001685, issued on 11/10/2020, had Jennifer Smith listed as the designated responsible party. License CCL20-0001685 was an Annual Adult-Use, Small Outdoor cultivation license with the business name Canvas Farms. License CCL20-0001685 expired on 11/10/2023.
