Amendment No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE AND CRESTWOOD BEHAVIORAL HEALTH FOR ADULT RESIDENTIAL SUPPORT SERVICES AND SPECIALTY MENTAL HEALTH SERVICES FOR FISCAL YEARS 2022-23, 2023-24, and 2024-25

This Amendment Number One to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Crestwood Behavioral Health, hereinafter referred to as "Contractor," collectively referred to as the "parties."
