**RESOLUTION TO APPROPRIATE UNANTICIPATED REVENUE IN BU 1120 NON-DEPARTMENTAL REVENUE**

WHEREAS, Government Code Section 29130 provides that unanticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board of Supervisors at any regularly scheduled or properly noticed special meeting; and

WHEREAS, Current property taxes received in Fiscal Year 2024-25 are expected to come in marginally higher than anticipated; and

WHEREAS, County of Lake is required to make a debt service payment in the amount of \$217,532.22 for interest on the 2025 Lease Revenue Bond; and

WHEREAS, It is necessary to add appropriations to BU 1120 Non-Departmental Revenue for the purpose of completing the payment;

NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors, County of Lake, State of California, that the following revisions to the Fiscal Year 2024-25 Budget of the County of Lake are hereby ordered and approved as follows:
