BOARD OF SUPERVISORS, COUNTY OF LAKE STATE OF CALIFORNIA ORDINANCE NO. 2958

AN ORDINANCE AMENDING ARTICLE II OF CHAPTER 2 OF THE LAKE COUNTY CODE ESTABLISHING THE BOUNDARIES OF THE SUPERVISORIAL DISTRICTS FOR THE COUNTY OF LAKE PURSUANT TO SECTIONS 21500 ET SEQ. OF THE ELECTIONS CODE

THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

SECTION 1: Article II of Chapter 2 of the Lake County Code is hereby amended to read as follows:

Article II, SUPERVISORIAL DISTRICTS

Sec 2-4. Declaration.

- 4.1 The purpose of this article is to establish the boundaries of the Supervisorial Districts for the County of Lake pursuant to Section 21500 et seq. of the Elections Code.
- 4.2 Pursuant to Section 21500 of the Elections Code and using the decennial federal census of 2010 as a basis, the Board of Supervisors of the County of Lake has adjusted the boundaries of supervisorial districts for the County of Lake so that said districts are as nearly equal in population as may be.
- 4.3 The supervisorial Districts of the County of Lake are numbered and bounded as follows:

a. **SUPERVISORIAL DISTRICT NO. 1**:

BEGINNING on the boundary line between the Counties of Lake and Sonoma, at its intersection with the center of Socrates Mine Road, and running thence, in a general Northeasterly and Easterly direction, along the center of said Socrates Mine Road, a distance of 4-½ miles more or less to the center of California State Highway No. 175; thence Northwesterly, along the center of said State Highway, a distance of 300 feet more or less to the North line of the Southeast quarter of the Northeast quarter of Section 25, Township 11 North, Range 8 West; thence East, along the North line of said Southeast quarter of the Northeast quarter of Section 25, a distance of 250 feet more or less to the center of Putah Creek; thence Northwesterly, up the center of Putah Creek, a distance of ¾ mile more or less to the intersection with the center of Casa Grande Lane as shown on the parcel map recorded June 29, 1990 in Book 31 of Parcel Maps, at Pages 34-37, Lake County Records; thence in a general Southeasterly, Northwesterly and Easterly direction along the center of said Casa Grande Lane, also being the Southerly boundary of Parcel 1 as shown on said map, a distance of ¼

mile more or less to the corner common to said Parcel 1 and Parcel 2 as shown on said map; thence leaving said center of Casa Grande Lane in a Northerly direction along the common boundary of said Parcels 1 and 2, a distance of a 1/4 mile more or less to the intersection with the East-West quarter Section line of Section 24, Township 11 North, Range 8 West, Mount Diablo Meridian; thence Easterly, along said quarter section line and the North line of said Parcels 2 and 3 as shown on said map, a distance of 1,600 feet more or less to the quarter section corner common to said Section 24 and Section 19, Township 11 North, Range 7 West, Mount Diablo Meridian; thence leaving said North line of said Parcel 3, Northerly, along the West line of said Section 19, a distance of 1,320 feet more or less to the Southwest corner of Lot 1 of said Section 19; thence Easterly, along the South line of said Lot 1 and its Easterly extension, a distance of 1,900 feet more or less to the center of an existing unnamed road; thence in a general Northeasterly direction, along the center of said road, a distance of 1 mile more or less to the center of Boggs Mountain Springs road; thence continuing generally Northeasterly along said Boggs Mountain Springs road, a distance of 1-1/4 miles more or less to the intersection with the center of an existing unnamed road, said intersection being Easterly 700 feet more or less from the Northwest corner of Section 17, Township 11 North, Range 7 West, Mount Diablo Meridian; thence continuing in an Easterly and Northwesterly direction along the center of said unnamed road, a distance of ½ mile more or less to the intersection with the West line of Section 8 of said Township and Range from which the Southwest corner of said Section 8 bears Southerly 1/4 mile more or less; thence continuing Northwesterly along the center of said road, a distance of ½ mile more or less to the center of Malo Creek; thence in a general Northeasterly direction, down the center of Malo Creek, a distance of 1.6 miles more or less to the center of Big Canyon Road; thence in a general Northwesterly direction, along the center of said Big Canyon Road, a distance of 2-1/2 miles more or less to its intersection with the center of Big Canyon Creek; thence continuing in a general Easterly and Northerly direction along said center of Big Canyon Road, a distance of 3 miles more or less to the center of Seigler Canyon Road; thence in a general Northeasterly direction along the center of said Seigler Canyon Road, a distance of 4-1/4 miles more or less to the center of California State Highway No. 29; thence in a Westerly direction along the center of said State Highway, a distance of ½ mile more or less to the center of Point Lakeview Road; thence in a general Northwesterly and Northerly direction along the center of said Point Lakeview Road, a distance of 2-1/2 miles more or less to the center of Sunrise Drive; thence in a Northeasterly, Southerly and Northerly direction, along the center of said Sunrise Drive, a distance of 3/4 mile more or less to the center of Sunrise Court; thence in a Southerly direction along the center of said Sunrise Court, a distance of 500 feet more or less to the Northwesterly line of Parcel "B" as shown on the parcel map recorded February 24, 1981 in Book 19 of Parcel Maps, at Pages 44 and 45, Lake County Records; thence North 46°56'40" East, along said Northwesterly line, a distance of 350 feet more or less to the Low Water Line of Clear Lake; thence in a general Southeasterly and Northwesterly direction, along the Low Water Line of Clear Lake, a distance of 12 miles more or less to a point on the Northwesterly line of Lot 26 in Block 41, as shown on the map of "Club House Addition to Clear Lake Highlands, Third Portion of Tracts A & B," filed October 15, 1924 in Book 4 of Town Maps at Page 4; thence North 27°30' East, along said Northwesterly line and its Northeasterly extension, a distance of 300 feet more or less to the center of Lakeshore Drive; thence Southeasterly and Easterly, along the center of said Lakeshore Drive 3,250 feet more or less to the center of Old Highway 53; thence Southerly, along the center of Old Highway 53, a distance of ½ mile more or less to the center of Cass Avenue; thence Easterly, along the center of said Cass Avenue, a distance of 650 feet more or less to the center of Jones Avenue; thence Southerly, along the center of said Jones Avenue, a distance of 700 feet more or less to the center of Cypress Avenue; thence Westerly, along the center of said Cypress Avenue, a distance of 200 feet more or less to the center of Huron Avenue; thence Southeasterly, along the center of said Huron Avenue, a distance of 700 feet more or less to the center of Crawford Avenue; thence Southerly, along the center of said Crawford Avenue, a distance of 250 feet more or less to the center of Old Highway 53; thence in a general Southeasterly direction, along the center of said Old Highway 53, a distance of 1 mile more or less to the center of California State Highway No. 53; thence Southeasterly, along the center of said State Highway, a distance of 2,000 feet more or less to the center of Cache Creek; thence in a general Easterly direction, down the center of said Cache Creek, a distance of 22 miles more or less to its intersection with the County line between the Counties of Lake and Yolo; thence, in a general Westerly, Southerly, Southwesterly and Northwesterly direction, along the County line of the Counties of Lake and Yolo, Lake and Napa, and Lake and Sonoma to the Point of Beginning. Together with those certain Islands commonly known as Indian Island, Garner Island and Slater Island, lying within Sections 28, 33 and 34, Township 13 North, Range 7 West, Mount Diablo Meridian.

b. SUPERVISORIAL DISTRICT NO. 2:

BEGINNING at the intersection of the centerline of California State Highway No. 20 with the centerline of California State Highway No. 53; thence in a general Easterly direction, along the center of said State Highway 20, a distance of 13 miles more or less to its intersection with the County line between the Counties of Lake and Colusa; thence, in a general Southeasterly and Westerly direction, along the County line between the Counties of Lake and Colusa, and Lake and Yolo to its intersection with the center of Cache Creek on the South line of Section 35, Township 13 North, Range 5 West; thence in a general Westerly direction, up the center of Cache Creek, a distance of 22 miles more or less to its intersection with the center of California State Highway No. 53; thence Northwesterly, along the center of said State Highway, a distance of 2,000 feet more or less to the center of Old Highway 53; thence in a general Northwesterly direction, along the center of said Old Highway 53, a distance of 1 mile more or less to the center of Crawford Avenue; thence Northerly, along the center of said Crawford Avenue, a distance of 250 feet more or less to the center of Huron Avenue; thence Northwesterly, along the center of said Huron Avenue, a distance of 700 feet more or less to the center of Cypress Avenue; thence Easterly, along the center of said Cypress Avenue, a distance of 200 feet more or less to the center of Jones Avenue; thence Northerly, along the center of said Jones Avenue, a distance of 700 feet more or less to the center of Cass Avenue; thence Westerly, along the center of said Cass Avenue, a distance of 650 feet more or less to the center of said Old Highway 53; thence Northerly, along the center of said Old Highway 53, a distance of ½ mile more or less to the center of Lakeshore Drive; thence Westerly and Northwesterly, along the center of said Lakeshore Drive, a distance of 3,250 feet more or less to the Northeasterly extension of the Northwesterly line of Lot 26 in Block 41, as shown on the map of "Club House Addition to Clear Lake Highlands, Third Portion of Tracts A & B", filed October 15, 1924 in Book 4 of Town Maps at Page 4; thence South 27°30' West, along said Northwesterly line of Lot 26 and its Northeasterly extension, a distance of 300 feet more or less to the Low Water Line of Clear Lake; thence in a general Northwesterly direction, along the Low Water Line of Clear Lake, a distance of 5 miles more or less to the City of Clearlake boundary being the Northerly line of that certain subdivision entitled "Oakmont Park," Subdivision No. 2" filed in Book 7 of Town Maps at Pages 44 and 45; thence South 83°57'00" East along said Northerly line of said "Oakmont Park Subdivision", a distance of 325 feet more or less to the Northeast corner of Block B of said subdivision; thence continuing along said City boundary South 83°57'00" East, a distance of 20 feet more or less to the center of Lakeshore Drive; thence, in a

general Easterly direction, along the center of said Lakeshore Drive, a distance of 34 mile to the intersection with the Southerly extension of the Easterly line of that certain tract of land as conveyed to Steve J. Halmo and June M. Halmo recorded November 18, 1975 in Book 813 of Official Records, Page 569, Lake County Records; thence North 26°26'42" East, along said Southerly extension, a distance of 20 feet to the Southeast corner of said Halmo tract; thence continuing North 26°26'42" East, along said tract, a distance of 431.06 feet to the Northeast corner thereof; thence North 75°29'45" West, along the Northerly line of said tract, a distance of 170 feet more or less to the West line of Section 18, Township 13 North, Range 7 West, Mount Diablo Meridian; thence North, along said West line, a distance of 500 feet more or less to the Northwest corner of said Section 18 said point also being the Southwest corner of Section 7; thence continuing North, along the West line of Section 7 of said Township and Range, a distance of 3/4 mile more or less to the center of Sulphur Bank Drive; thence in a general Easterly direction, along the center of said Sulphur Bank Drive, a distance of 1/4 mile more or less to the intersection with the East line of the Northwest quarter of the Northwest quarter of said Section 7; thence South, along said East line, a distance of 50 feet more or less to the Southeast corner of said Northwest quarter of the Northwest quarter; thence East, along the South line of the North half of the North half of said Section 7, a distance of 3,960 feet more or less to the Northwest corner of the Southwest quarter of the Northwest quarter of Section 8 of said Township and Range; thence along the boundary of said Southwest quarter of the Northwest quarter of said Section 8 the following three courses:

South, a distance of 1,320 feet more or less to the Southwest corner thereof; thence East, a distance of 1,320 feet more or less to the Southeast corner thereof; thence North, a distance of 1,320 feet more or less to the Northeast corner thereof; thence South 71°45'00" East, a distance of 66 feet more or less to the Westerly terminus of the course designated as "South 88°30' West, 236.28 feet" in Exhibit "A" of the City of Clearlake boundary; thence North 88°30'00" East, a distance of 236.28 feet; thence South 72°45'00" East, a distance of 205.92 feet; thence South 49°50'00" East, a distance of 188.76 feet; thence South 31°50'00" East, a distance of 808.50 feet; thence South 81°30'00" East, a distance of 431.64 feet; thence South 67°00'00" East, a distance of 238.26 feet; thence South 37°00'00" East, a distance of 375.54 feet more or less to the North line of the North half of the Southeast quarter of said Section 8; thence West, along said North line, a distance of 650 feet more or less to the Northwest corner of said North half of the Southeast quarter; thence South, along the West line of said North half of the Southeast quarter, a distance of 1,320 feet more or less to the Southwest corner of said North half of the Southeast quarter; thence East, along the South line of said North half of the Southeast quarter, a distance of 1,950 feet more or less to the Northwesterly terminus of the course designated as "North 29°00' West, 669 feet" in said Exhibit "A"; thence South 29°00'00" East, a distance of 669 feet; thence South 53°40'00" East, a distance of 427.68 feet; thence South 48°30'00" East, a distance of 225.06 feet; thence South 39°00'00" East, a distance of 175.56 feet; thence South 46°30'00" West, a distance of 349.80 feet to the Southeast corner of said Section 8; thence West, along the section line common to said Section 8 and Section 17 of said Township and Range, a distance of 1,320 feet more or less to the Northwest corner of the Northeast quarter of the Northeast quarter of said Section 17; thence South, along the West line of said Northeast quarter of the Northeast quarter, a distance of 528 feet more or less to the Northwesterly terminus of the course designated as "North 79°45' West, 603.24 feet" in said Exhibit "A": thence South 79°45'00" East, a distance of 603.24 feet; thence South 14°30'00" West, a distance of 114.84 feet; thence South 22°30'00" West, a distance of 586.74 feet; thence South 53°15'00" East, a distance of 955.68 feet; thence South 52°45'00" East, a distance of 627.66 feet; thence South 47°30'00" East, a distance of 403.92 feet; thence South 46°00'00" East, a distance of

1,986.40 feet more or less to a point that is 1,908 feet Easterly of the Southwest corner of the Northwest quarter of the Southwest quarter of Section 16 of said Township and Range; thence East, along the North line of the Southeast quarter of the Southwest quarter of said Section 16, a distance of 730 feet more or less to the Northeast corner of said Southeast quarter of the Southwest quarter of said Section 16; thence South, along the East line of said Southeast quarter of the Southwest quarter, a distance of 1,320 feet more or less to the quarter corner common to said Sections 16 and 21 of said Township and Range; thence East, along the South line of said Section 16, a distance of 1,960 feet; thence North, a distance of 2,640 feet more or less to the East-West guarter section line of said Section 16; thence East, along said East-West line, a distance of 680 feet more or less to the quarter section corner common to Section 15 and said Section 16; thence South, along the section line common to said Sections 15 and 16, a distance of 1,320 feet more or less to the Southwest corner of the Northwest quarter of the Southwest quarter; thence East, a distance of 1,320 feet more or less to the Southwest corner of the Northeast quarter of the Southwest quarter of said Section 15; thence North, a distance of 1,320 feet more or less to the Northwest corner thereof; thence East, a distance of 1,320 feet more or less to the Northeast corner thereof, also being the center of said Section 15; thence North, a distance of 1,320 feet more or less to the Northwest corner of the Southwest quarter of the Northeast quarter of said Section 15; thence East, a distance of 1,320 feet more or less to the Northeast corner thereof; thence South, a distance of 1,320 feet more or less to the Southeast corner thereof; thence East, along the East-West quarter section line of said Section 15, a distance of 1,320 feet more or less to the quarter section corner common to said Section 15 and Section 14; thence North along the Section line between said Sections 14 and 15, a distance of 2,640 feet more or less to the Northwest corner of said Section 14 said point also being the Northeast corner of said Section 15; thence leaving said City of Clearlake boundary, Westerly, along the North line of said Section 15, a distance of 120 feet more or less to the center of California State Highway No. 53; thence Northerly, along said center of said Highway No. 53, a distance of 2 miles more or less to the intersection with the center of California State Highway No. 20 and the Point of Beginning.

c. **SUPERVISORIAL DISTRICT NO. 3:**

BEGINNING on the boundary line between the Counties of Lake and Mendocino at its intersection with the South line of Section 16, Township 15 North, Range 11 West, Mount Diablo Meridian, and running thence East, along the South line of Sections 16, 15, 14 and 13, said Township and Range, a distance of 3 miles more or less to the range line between Ranges 10 and 11 West; thence South, along said Range line, a distance of 1/4 mile more or less to the quarter corner on the West line of Section 18, Township 15 North, Range 10 West; thence East, along the quarter section line running East and West through said Section 18, a distance of 1/2 mile more or less to the center: of said Section 18; thence South, along the quarter section line running North and South through said Section 18, a distance of ½ mile more or less to the quarter corner on the South line of said Section 18; thence East, along the South line of Sections 18, 17, 16, 15, 14 and 13, Township 15 North, Range 10 West, a distance of 5-1/4 miles more or less to the center of California State Highway No. 29; thence Southeasterly and Southerly, along the center of said State Highway, a distance of 1-34 miles more or less to its intersection with the center of Nice-Lucerne Cutoff; thence in a general Easterly direction, along said center of Nice-Lucerne Cutoff, a distance of 1 mile more or less to the Low Water Line of Clear Lake on the Easterly edge of Rodman Slough; thence in a general Easterly, Southeasterly, Easterly and Southwesterly direction, along said Low Water Line of Clear Lake, a

distance of 28 miles more or less to the City of Clearlake boundary being the Northerly line of that certain subdivision entitled "Oakmont Park, Subdivision No. 2" filed in Book 7 of Town Maps at pages 44 and 45; thence South 83°57′00" East along said Northerly line of said "Oakmont Park Subdivision", a distance of 325 feet more or less to the Northeast corner of Block B of said subdivision; thence continuing along said City boundary South 83°57′00″ East, a distance of 20 feet more or less to the center of Lakeshore Drive; thence, in a general Easterly direction, along the center of said Lakeshore Drive, a distance of 34 mile to the intersection with the Southerly extension of the Easterly line of that certain tract of land as conveyed to Steve J. Halmo and June M. Halmo recorded November 18, 1975 in Book 813 of Official Records, Page 569, Lake County Records; thence North 26°26'42" East, along said Southerly extension, a distance of 20 feet to the Southeast corner of said Halmo tract; thence continuing North 26°26'42" East, along said tract, a distance of 431.06 feet to the Northeast corner thereof; thence North 75°29'45" West, along the Northerly line of said tract, a distance of 170 feet more or less to the West line of Section 18, Township 13 North, Range 7 West, Mount Diablo Meridian; thence North, along said West line, a distance of 500 feet more or less to the Northwest corner of said Section 18 said point also being the Southwest corner of Section 7; thence continuing North, along the West line of Section 7 of said Township and Range, a distance of 34 mile more or less to the center of Sulphur Bank Drive; thence in a general Easterly direction, along the center of said Sulphur Bank Drive, a distance of 1/4 mile more or less to the intersection with the East line of the Northwest quarter of the Northwest quarter of said Section 7; thence South, along said East line, a distance of 50 feet more or less to the Southeast corner of said Northwest quarter of the Northwest quarter; thence East, along the South line of the North half of the North half of said Section 7, a distance of 3,960 feet more or less to the Northwest corner of the Southwest quarter of the Northwest guarter of Section 8 of said Township and Range; thence along the boundary of said Southwest quarter of the Northwest quarter of said Section 8 the following three courses:

thence West, along said North line, a distance of 650 feet more or less to the Northwest corner of said North half of the Southeast quarter; thence South, along the West line of said North half of the Southeast quarter, a distance of 1,320 feet more or less to the Southwest corner of said North half of the Southeast quarter; thence East, along the South line of said North half of the Southeast quarter, a distance of 1,950 feet more or less to the Northwesterly terminus of the course designated as "North 29°00' West, 669 feet" in said Exhibit "A"; thence South 29°00'00" East, a distance of 669 feet; thence South 53°40'00" East, a distance of 427.68 feet; thence South 48°30'00" East, a distance of 225.06 feet; thence South 39°00'00" East, a distance of 175.56 feet; thence South 46°30'00" West, a distance of 349.80 feet to the Southeast corner of said Section 8; thence West, along the Section line common to said Section 8 and Section 17 of said Township and Range, a distance of 1,320 feet more or less to the Northwest corner of the Northeast quarter of the Northeast quarter of said Section 17; thence South, along the West line of said Northeast quarter of the Northeast quarter, a distance of 528 feet more or less to the Northwesterly terminus of the course designated as "North 79°45' West, 603.24 feet" in said Exhibit "A"; thence South 79°45'00" East, a distance of 603.24 feet; thence South 14°30'00" West, a distance of 114.84 feet; thence South 22°30'00" West, a distance of 586.74 feet; thence South 53°15'00" East, a distance of 955.68 feet; thence South 52°45'00" East, a distance of 627.66 feet; thence South 47°30'00" East, a distance of 403.92 feet; thence South 46°00'00" East, a distance of 1,986.40 feet more or less to a point that is 1,908 feet Easterly of the Southwest corner of the Northwest quarter of the Southwest quarter of Section 16 of said Township and Range; thence East, along the North line of the Southeast quarter of the Southwest quarter of said Section 16, a distance of 730 feet more or less to the Northeast corner of said Southeast quarter of the Southwest quarter of said Section 16; thence South, along the East line of said Southeast quarter of the Southwest quarter, a distance of 1,320 feet more or less to the quarter corner common to said Sections 16 and 21 of said Township and Range; thence East, along the South line of said Section 16, a distance of 1,960 feet; thence North, a distance of 2,640 feet more or less to the East-West quarter section line of said Section 16; thence East, along said East-West line, a distance of 680 feet more or less to the quarter section corner common to Section 15 and said Section 16; thence South, along the Section line common to said Sections 15 and 16, a distance of 1,320 feet more or less to the Southwest corner of the Northwest quarter of the Southwest quarter; thence East, a distance of 1,320 feet more or less to the Southwest corner of the Northeast quarter of the Southwest quarter of said Section 15; thence North, a distance of 1,320 feet more or less to the Northwest corner thereof; thence East, a distance of 1,320 feet more or less to the Northeast corner thereof, also being the center of said Section 15; thence North, a distance of 1,320 feet more or less to the Northwest corner of the Southwest quarter of the Northeast quarter of said Section 15; thence East, a distance of 1,320 feet more or less to the Northeast corner thereof; thence South, a distance of 1,320 feet more or less to the Southeast corner thereof; thence East, along the East-West quarter Section line of said Section 15, a distance of 1,320 feet more or less to the quarter section corner common to said Section 15 and Section 14; thence North along the Section line between said Sections 14 and 15, a distance of 2,640 feet more or less to the Northwest corner of said Section 14 said point also being the Northeast corner of said Section 15; thence leaving said City of Clearlake boundary, Westerly, along the North line of said Section 15, a distance of 120 feet more or less to the center of California State Highway No. 53; thence Northerly, along said center of said Highway No. 53, a distance of 2 miles more or less to the intersection with the center of California State Highway No. 20; thence in a general Easterly direction, along the center of said State Highway, a distance of 13 miles more or less to its intersection with County line between the Counties of Lake and Colusa; thence in a general Northerly, Westerly and Southerly direction, along the County line between the Counties of Lake and Colusa, Lake and Glen, and Lake and Mendocino to the Point of Beginning. Together with those certain Islands commonly known as Fruit Island and Weekend Island, within Section 3, Township 13 North, Range 8 West, and Rattlesnake Island, within Section 6, Township 13 North, Range 7 West and Section 31, Township 14 North, Range 7 West, Mount Diablo Meridian.

d. **SUPERVISORIAL DISTRICT NO. 4**:

BEGINNING on the boundary line between the Counties of Lake and Mendocino at its intersection with the South line of Section 16, Township 15 North, Range 11 West, Mount Diablo Meridian, and running thence East, along the South line of Sections 16, 15, 14 and 13, said Township and Range, a distance of 3 miles more or less to the range line between Ranges 10 and 11 West; thence South, along said range line, a distance of 1/4 mile more or less to the quarter corner on the

West line of Section 18, Township 15 North, Range 10 West; thence East, along the quarter section line running East and West through said Section 18, a distance of ½ mile more or less to the center of said Section 18; thence South, along the quarter section line running North and South through said Section 18, a distance of 1/2 mile more or less to the quarter corner on the South line of said Section 18; thence East, along the South line of Sections 18, 17, 16, 15, 14 and 13, Township 15 North, Range 10 West, a distance of 5-1/4 miles more or less to the center of California State Highway No. 29; thence Southeasterly and Southerly, along the center of said State Highway, a distance of 1-34 miles more or less to its intersection with the center of Nice-Lucerne Cutoff; thence in a general Easterly direction, along said center of Nice-Lucerne Cutoff, a distance of 1 mile more or less to the Low Water Line of Clear Lake on the Westerly edge of Rodman Slough; thence in a general Southwesterly, Southerly and Easterly direction, along said Low Water Line of Clear Lake, a distance of 25 miles more or less to the intersection with a line extended due East from the end of an existing unnamed road, said point of intersection being near the most Easterly corner of Lot 1 of Section 5, Township 13 North, Range 8 West, Mount Diablo Meridian, as described in Doc No. 2004010073, Lake County Records; thence leaving said Low Water Line of Clear Lake, West, along said extended line, 200 feet more or less to the end of said existing road; thence in a general Westerly and Southerly direction along said road a distance of a 1/4 mile more or less to the center of Soda Bay Road; thence in a general Southeasterly direction along the center of Soda Bay Road, a distance of 1-1/4 miles more or less to the intersection with the East line of said Section 5; thence Southerly, along said East line, a distance of 200 feet more or less to the Southeast corner of said Section 5; thence Westerly, along the South line of Sections 5 and 6, Township 13 North, Range 8 West and Section 1, Township 13 North, Range 9 West, Mount Diablo Meridian, a distance of 2-1/2 miles more or less to the center of Jamie Lane; thence Northwesterly, along the center of Jamie Lane, a distance of 200 feet more or less to the center of Glebe Road; thence Northwesterly, along the center of Glebe Road, a distance of ½ mile more or less to the center of Clark Drive, thence Southerly, along the center of Clark Drive and its Southerly extension, a distance of 500 feet more or less to the South line of said Section 1; thence Westerly, along the South line of Sections 1 and 2, Township 13 North, Range 9 West, a distance of 34 mile more or less to the center of Gaddy Lane; thence Southerly and Westerly, along the center of Gaddy Lane, a distance of 1-34 miles more or less to the center of Merritt Road; thence Westerly, along the center of Merritt Road, a distance of 925 feet more or less to the center of North Main Street; thence continuing Westerly along the center of Merritt Road, a distance of ½ mile more or less to the center of said State Highway No. 29; thence in a general Southeasterly direction along the center of said State Highway a distance of 34 mile more or less to the center of Bell Hill Road; thence in a general Southerly, Westerly, and Southwesterly direction, along the center of Bell Hill Road, a distance of 3-1/2 miles more or less to the center of Adobe Creek Road; thence Southerly and Southeasterly, along the center of Adobe Creek Road, a distance of 2-1/4 miles more or less to the centerline of Peterson Lane; thence Southwesterly, along the center of Peterson Lane, a distance of 650 feet more or less to the center of Adobe Creek; thence in a general Southerly direction, up the center of Adobe Creek, a distance of 3-1/2 miles more or less to its intersection with the County line between Lake and Mendocino Counties; thence in a general Northwesterly and Northerly direction, along said County line to the Point of Beginning.

BEGINNING on the boundary line between the Counties of Lake and Sonoma, at its intersection with the center of Socrates Mine Road, and running thence, in a general Northeasterly and Easterly direction, along the center of said Socrates Mine Road, a distance of 4-1/2 miles more or less to the center of California State Highway No. 175; thence Northwesterly, along the center of said State Highway, a distance of 300 feet more or less to the North line of the Southeast quarter of the Northeast quarter of Section 25, Township 11 North, Range 8 West; thence East, along the North line of said Southeast quarter of the Northeast quarter of Section 25, a distance of 250 feet more or less to the center of Putah Creek; thence Northwesterly, up the center of Putah Creek, a distance of 34 mile more or less to the intersection with the center of Casa Grande Lane as shown on the parcel map recorded June 29, 1990 in Book 31 of Parcel Maps, at Pages 34-37, Lake County Records; thence in a general Southeasterly, Northwesterly and Easterly direction along the center of said Casa Grande Lane, also being the Southerly boundary of Parcel 1 as shown on said map, a distance of 1/4 mile more or less to the corner common to said Parcel 1 and Parcel 2 as shown on said map; thence leaving said center of Casa Grande Lane in a Northerly direction along the common boundary of said Parcels 1 and 2, a distance of a 1/4 mile more or less to the intersection with the East-West quarter Section line of Section 24, Township 11 North, Range 8 West, Mount Diablo Meridian; thence Easterly, along said guarter section line and the North line of said Parcels 2 and 3 as shown on said map, a distance of 1,600 feet more or less to the quarter section corner common to said Section 24 and Section 19, Township 11 North, Range 7 West, Mount Diablo Meridian; thence leaving said North line of said Parcel 3, Northerly, along the West line of said Section 19, a distance of 1,320 feet more or less to the Southwest corner of Lot 1 of said Section 19; thence Easterly, along the South line of said Lot 1 and its Easterly extension, a distance of 1,900 feet more or less to the center of an existing unnamed road; thence in a general Northeasterly direction, along the center of said road, a distance of 1 mile more or less to the center of Boggs Mountain Springs road; thence continuing generally Northeasterly along said Boggs Mountain Springs road, a distance of 1-1/4 miles more or less to the intersection with the center of an existing unnamed road, said intersection being Easterly 700 feet more or less from the Northwest corner of Section 17, Township 11 North, Range 7 West, Mount Diablo Meridian; thence continuing in an Easterly and Northwesterly direction along the center of said unnamed road, a distance of ½ mile more or less to the intersection with the West line of Section 8 of said Township and Range from which the Southwest corner of said Section 8 bears Southerly 1/4 mile more or less; thence continuing Northwesterly along the center of said road, a distance of ½ mile more or less to the center of Malo Creek; thence in a general Northeasterly direction, down the center of Malo Creek, a distance of 1.6 miles more or less to the center of Big Canyon Road; thence in a general Northwesterly direction, along the center of said Big Canyon Road, a distance of 2-1/2 miles more or less to its intersection with the center of Big Canyon Creek; thence continuing in a general Easterly and Northerly direction along said center of Big Canyon Road, a distance of 3 miles more or less to the center of Seigler Canyon Road; thence in a general Northeasterly direction along the center of said Seigler Canyon Road, a distance of 4-1/4 miles more or less to the center of California State Highway No. 29; thence in a Westerly direction along the center of said State Highway, a distance of 1/2 mile more or less to the center of Point Lakeview Road; thence in a general Northwesterly and Northerly direction along the center of said Point Lakeview Road, a distance of 2-1/2 miles more or less to the center of Sunrise Drive; thence in a Northeasterly, Southerly and Northerly direction, along the center of said Sunrise Drive, a distance of 3/4 mile more or less to the center of Sunrise Court; thence in a Southerly direction along the center of said Sunrise

Court, a distance of 500 feet more or less to the Northwesterly line of Parcel "B" as shown on the parcel map recorded February 24, 1981 in Book 19 of Parcel Maps, at Pages 44 and 45, Lake County Records; thence North 46°56'40" East, along said Northwesterly line, a distance of 350 feet more or less to the Low Water Line of Clear Lake; thence in a general Northerly, Westerly and Northwesterly direction, along said Low Water Line of Clear Lake, a distance of 22 miles more or less to the intersection with a line extended due East from the end of an existing unnamed road, said point of intersection being near the most Easterly corner of Lot 1 of Section 5, Township 13 North, Range 8 West, Mount Diablo Meridian, as described in Doc No. 2004010073, Lake County Records; thence leaving said Low Water Line of Clear Lake, West, along said extended line, 200 feet more or less to the end of said existing road; thence in a general Westerly and Southerly direction along said road a distance of a ¼ mile more or less to the center of Soda Bay Road; thence in a general Southeasterly direction along the center of Soda Bay Road, a distance of 1-1/4 miles more or less to the intersection with the East line of said Section 5; thence Southerly, along said East line, a distance of 200 feet more or less to the Southeast corner of said Section 5; thence Westerly, along the South line of Sections 5 and 6, Township 13 North, Range 8 West and Section 1, Township 13 North, Range 9 West, Mount Diablo Meridian, a distance of 2-1/2 miles more or less to the center of Jamie Lane; thence Northwesterly, along the center of Jamie Lane, a distance of 200 feet more or less to the center of Glebe Road; thence Northwesterly, along the center of Glebe Road, a distance of 1/2 mile more or less to the center of Clark Drive, thence Southerly, along the center of Clark Drive and its Southerly extension, a distance of 500 feet more or less to the South line of said Section 1; thence Westerly, along the South line of Sections 1 and 2, Township 13 North, Range 9 West, a distance of 3/4 mile more or less to the center of Gaddy Lane; thence Southerly and Westerly, along the center of Gaddy Lane, a distance of 1-34 miles more or less to the center of Merritt Road; thence Westerly, along the center of Merritt Road, a distance of 925 feet more or less to the center of North Main Street; thence continuing Westerly along the center of Merritt Road, a distance of ½ mile more or less to the center of said State Highway No. 29; thence in a general Southeasterly direction along the center of said State Highway a distance of 3/4 mile more or less to the center of Bell Hill Road; thence in a general Southerly, Westerly, and Southwesterly direction, along the center of Bell Hill Road, a distance of 3-1/2 miles more or less to the center of Adobe Creek Road; thence Southerly and Southeasterly, along the center of Adobe Creek Road, a distance of 2-1/4 miles more or less to the centerline of Peterson Lane; thence Southwesterly, along the center of Peterson Lane, a distance of 650 feet more or less to the center of Adobe Creek; thence in a general Southerly direction, up the center of Adobe Creek, a distance of 3-1/2 miles more or less to its intersection with the County line between Lake and Mendocino Counties; thence in a general Southeasterly direction, along said County line, and along the County line between Lake and Sonoma Counties, a distance of 13 miles more or less to the center of Socrates Mine Road and the Point of Beginning. Together with that certain Island commonly known as Anderson Island lying within Section 33, Township 14 North, Range 8 West.
