

FIRST AMENDMENT TO CONTRACT BETWEEN COUNTY OF LAKE AND PRENTICE LONG FOR PUBLIC AUTHORITY LABOR NEGOTIATIONS

This First Amendment to the Contract is made by and between the County of Lake through its Department of Social Services, hereinafter referred to as "LCDSS", and Prentice Long, hereinafter referred to as "Contractor"; collectively referred to as the "parties".

WHEREAS, the original Contract was fully executed on March 9, 2021 for the term of February 1, 2021 to January 31, 2022, and

WHEREAS, there is a desire to extend the term for two (2) additional years, and

WHEREAS, change the compensation terms to accommodate the extension in term.

NOW, THEREFORE, the parties hereto agree as follows:

1. Page 1, section 1 entitled "Term", sentence 1, is hereby amended to read as follows, "This Contract shall commence on February 1, 2021 and shall terminate on January 31, 2024".
2. Page 1, Section 2, entitled "Compensation", paragraph 1, is hereby amended to read as follows, "Contractor has been selected by LCDSS to provide the services described hereunder in Exhibit "A" (Scope of Services), incorporated herein by this reference. Compensation to Contractor shall not exceed thirty thousand dollars (\$30,000) per year."

Except as specifically modified herein, all other terms and conditions of the original Contract shall remain in full force and effect.
