**A RESOLUTION DECLARING INTENT TO VACATE A ROADWAY KNOWN AS  
DILLARD AVENUE, COUNTY ROAD NO.502BD, IN THE COUNTY OF LAKE**

**WHEREAS a petition has been received to vacate a roadway known as Dillard Avenue located in the Kelseyville area of the County of Lake, State of California; and**

**WHEREAS it appears to be in the best interest of the County of Lake to vacate the portions of said County road; and**

**WHEREAS it is appropriate to set a date and time for the public hearing to consider the proposed vacation by the Board of Supervisors;**

**NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE, STATE OF CALIFORNIA, THAT IT FINDS, DETERMINES, ORDERS AND HEREBY DECLARES THAT:**

**1. It is the intention of the Board to vacate the hereinafter described roadway in the County of Lake, State of California described as follows: All of Dillard Avenue as shown on that certain map entitled "Soda Bay Springs Subdivision" filed in the office of the County Recorder of said Lake County on October 4, 1923 in Book 3 of Town Maps at Pages 50 to 51 inclusive and as described in Exhibit "A" attached.**

**2. Tuesday, the 11th day of January 2022, at Lakeport @10AM is fixed as the time, and the Board of Supervisors Chambers, Courthouse, Lakeport, California, is fixed as the place for hearing all persons interested in the proposed vacation.**

**3. This vacation proceeding is being conducted under the provisions of the Public Streets, Highways, and Service Easements Vacation Law (Streets and Highways Code, Section 8321, et. Seq.).**

4. The Clerk of the Board is directed to give notice hereof pursuant to Sections 8322 and 8323 of the Streets and Highways Code.
