

BOARD OF SUPERVISORS, COUNTY OF LAKE, STATE OF CALIFORNIA RESOLUTION NO. _____

A RESOLUTION AMENDING THE MASTER FEE SCHEDULE FOR DEPARTMENTAL SERVICES RENDERED BY THE COUNTY

WHEREAS, the Board of Supervisors has previously adopted a Master Fee Schedule establishing County of Lake and State approved fees for permits, services, and other such legal instruments which grant permission or authority to conduct specific activities or to exercise a certain privilege; and

WHEREAS, section 2-203 of the County of Lake Ordinance Code provides that said Master Fee Schedule may be amended by Resolution during the annual budget process, and at other times of the fiscal year as necessary; and

WHEREAS, the Master Fee Schedule now needs further revision to sections pertaining to Behavioral Health, the Building Safety Division, Code Enforcement, County Counsel, Environmental Health, Information Technology, the Library, Planning Division and Support Services, Public Services, Department of Public Works, Registrar of Voters/ Elections Department, Sheriff/Coroner, and Water Resources.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, County of Lake, State of California, as follows:

- (1) The fees and charges as set forth in Exhibit "A" supersede the fees and charges previously adopted to the extent such previous fees and charges are inconsistent with the fees and charges set forth in the attached Exhibit "A".
- (2) The fees and charges set forth in the attached Exhibit "A" shall take effect on 07/01/2022 notwithstanding any provision to the contrary, with the exception of Building and Planning fees governed by 66017. (a) of the Government Code which will become effective 60 days after adoption.
