My firm, Realm Engineering, has been hired to prepare a Hydrology Study for a proposed cannabis cultivation operation at [9261 Wildcat Road](#) near Kelseyville, CA. Currently, we are trying to determine if there are permitted wells on the properties closest to my clients' water supply well, Lake County APNs 011-044-15, 011-058-06, and 011-058-14. I used the California Department of Water Resources' Well Completion Report Map Application to obtain several well completion reports that could be associated with wells on these properties, but the reports are older and provide vague location information. Additionally, it appears that some of the APNs identified in the well completion reports have changed. Would you be able to provide me with information on the presence or absence of groundwater wells on the properties identified below? And if possible, site specific location information would be wonderful.
