

**Amendment No. 2 to the AGREEMENT BETWEEN COUNTY OF LAKE  
AND LAKE COUNTY OFFICE OF EDUCATION - SAFE SCHOOLS  
HEALTHY STUDENTS PROGRAM FOR SCHOOL-BASED SPECIALTY  
MENTAL HEALTH SERVICES FOR FISCAL YEAR 2021-22**

**This 2<sup>nd</sup> Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as “County,” and Lake County Office of Education, hereinafter referred to as “Contractor,” collectively referred to as the “parties.”**

**RECITALS**

**WHEREAS**, the parties hereto have entered into an Agreement dated July 1, 2021 under which Contractor will provide Specialty Mental Health Services to Lake County beneficiaries; and

**WHEREAS**, the parties Amended this Agreement on March 1, 2022 to increase the total compensation payable under the Agreement by \$100,000 for a new contract maximum of \$200,000; and

**WHEREAS**, the parties now desire to amend the Agreement a second time to increase the total compensation payable under the Agreement by \$100,000.00 for a new contract maximum of **Three Hundred Thousand Dollars (\$300,000.00)**.

**NOW, THEREFORE**, the parties hereto agree to the following Amendment to the Agreement:

**3. COMPENSATION.** Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, **“Scope of Services.” Compensation to Contractor shall not exceed Three Hundred Thousand Dollars (\$300,000.00).**

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
