- (3) The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS within <u>fifteen (15)</u> calendar days after the date of the NOTICE TO PROCEED and will complete the same within <u>Ninety (90)</u> working days unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
- (4) The CONTRACTOR agrees to perform all of the WORK described in the CONTRACT DOCUMENTS and comply with the terms therein for the sum of \$_1,492,809.74_, as shown in the contractors BID.
