NOTICE OF INTENT TO ADOPT A MAJOR USE PERMIT AND A MITIGATED NEGATIVE DECLARATION AND NOTICE OF A PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the County of Lake Planning Commission will hold a public hearing on Thursday June 23, 2022, 9:15 a.m. in the Board of Supervisors' Chambers, 255 N. Forbes Street, Lakeport, CA., to consider a MAJOR USE PERMIT (UP 21-06) and adoption of an Initial Study (IS 21-06) to satisfy the California Environmental Quality Act (CEQA) requirements related to potential environmental impacts. The project is located at 11795 North Drive, Clearlake Park, CA; further described as Assessor Parcel Numbers: 010-019-15 and 010-019-10.

PROJECT DESCRIPTION: To consider a proposal from Akwaaba, LLC for a major use permit two (2) A-Type 3 "Medium Outdoor" licenses with a total combined outdoor canopy area of 73,560 sq.ft., and an A-Type 2B "Small Mixed-Light" license with a total combined mixed-light canopy area of 9,720 sq.ft..
