RESOLUTION DECLARING INTENT TO NAME A CERTAIN EXISTING UNNAMED  
ROAD IN THE COUNTY OF LAKE  
(SNOW ROAD)

WHEREAS a petition has been received to name an unnamed road located in the Lower Lake area of the County of Lake, State of California; and

WHEREAS it is appropriate to set a date and time for the public hearing on this proposal for the Board of Supervisors to consider if it is in the best interest of the County of Lake to name said road;

NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LAKE, STATE OF CALIFORNIA, THAT IT FINDS, DETERMINES, ORDERS AND HEREBY DECLARES THAT:

1. Pursuant to the authority of the Master Grid Numbering System of the County of Lake, it is the intention of this Board to name that certain existing road in the County of Lake as follows:

1.) That certain roadway, approximately 0.14 mile in length, beginning at its intersection with Little High Valley Road in the Southeast quarter of the Northwest quarter of Section 30, Township 12 North, Range 6 West, M.D.M., said intersection being approximately 0.15 mile Westerly of the intersection of Little High Valley Road and Spruce Grove Road and running in a general Westerly direction to its terminus in Section 30 of Township 12 North, Range 6 West, M.D.M, and to be named Snow Road.

2. Tuesday, July 26, 2022, 2022, at 9:15 AM is fixed as the time, and the Board of Supervisors Chambers in the County Courthouse, Lakeport, California, is hereby fixed as the place for hearing all persons interested in the proposed road naming.

3. The Clerk of the Board of Supervisors is hereby directed to give notice thereof pursuant to the noticing provisions only of Section 970.5 of the Streets and Highways Code of the State of California. The road to be named is not considered a County Highway.
