# AMENDMENT No. 1 to the AGREEMENT BETWEEN COUNTY OF LAKE AND RESOURCE DEVELOPMENT ASSOCIATES FOR CONSULTATION AND SUPPORT IN THE COMMUNITY PROGRAM PLANNING (CPP) PROCESS AND THE EVALUATION OF THE WHOLE PERSON CARE GRANT PROJECT FOR FISCAL YEAR 2021-22 and 2022-23

This Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Resource Development Associates, hereinafter referred to as "Contractor," collectively referred to as the "parties."

#### **RECITALS**

**WHEREAS**, the parties hereto have entered into an Agreement dated July 1, 2021 under which contractor will provide consultation in Community Program Planning for the Mental Health Service Act and evaluation of the Whole Person Care Grant program; and

WHEREAS, the parties now desire to amend the Agreement to increase the total compensation payable under the Agreement by \$154,710.00 for a new contract maximum of Two Hundred Sixty-Eight Thousand, Sixty Dollars (\$268,060.00).

**NOW, THEREFORE,** the parties hereto agree to the following Amendment to the Agreement:

1. <u>SERVICES</u>. Subject to the terms and conditions set forth in this Agreement, Resource Development Associates shall provide to County the services described in the "Scope of Services" attached hereto and incorporated herein as Exhibit A at the time and place and in the manner specified therein. In the event of a conflict in or inconsistency between the terms of this Agreement and Exhibits A/B/C, the Agreement shall prevail.

### 4. DESCRIPTION OF SERVICES.

4.3 County shall increase reimbursement to Contractor for Community Program Planning services for the MHSA program annual update for FY 2021-22 by \$20,300.00, in addition to the work and amount specified in item 4.1 above, as itemized in the table below:

- 4.2 County shall pay Contractor One Hundred Eighty Thousand, Three Hundred Dollars (\$180,300.00) for CCP Services outlined in Exhibit A, items 4.3 and 4.4.

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
