HEARING AND ADOPT A MITIGATED NEGATIVE
DECLARATION**

NOTICE IS HEREBY GIVEN that the County of Lake Planning Commission will hold a public hearing to consider a General Plan Amendment and Rezone (files no. GPAP 19-03 and RZ 19-03) on Thursday July 14, 2022, 9:20 a.m., in the Board of Supervisors' Chambers, located at 255 N. Forbes Street, Lakeport, California. The Planning Commission will be asked to make a formal recommendation to the Board of Supervisors, which will occur during a later public hearing. The Commission will also consider the adoption of an Initial Study for a CEQA* evaluation (file no. IS 19-43). The applicant is Dennis De La Montanya; the project is located at 8255 Point Drive, Kelseyville, CA; APN: 044-331-24.

PROJECT DESCRIPTION: Rezoning and General Plan Amendment to change a 17.4+ acre lot from R1, Low Density Residential, to RR, Rural Residential. No development is proposed in conjunction with this action. The project is evaluated for being in accordance with Lake County General Plan, the Kelseyville Area Plan, and the Lake County Zoning Ordinance Article 10, R1 Low Density Residential; Article 8, Rural Residential; Article 47, Ordinance Text Amendment.

ALL INTERESTED are invited to be present at the public hearing. All persons may provide public comment at the time and place indicated above.
