NOTICE OF INTENT TO HOLD A PUBLIC HEARING AND ADOPT A CATEGORICAL EXEMPTION TO CEQA*

NOTICE IS HEREBY GIVEN that the County of Lake Planning Commission will hold a public hearing to consider a General Plan of Conformity (file no. GPC 21-03) for a property zoned "O-SC-FF-WW", Open Space - Scenic Combining - Floodway Fringe - Waterway that would, if approved, allow the County to make improvements to the Upper Lake County Park. The hearing for the General Plan of Conformity will take place on Thursday July 14, 2022, 9:25 a.m., in the Board of Supervisors' Chambers, located at 255 N. Forbes Street, Lakeport, California. The Planning Commission will also consider a Categorical Exemption (CE 21-68), per CEQA* section 15301. The project is located at 650 E. Highway 20, Upper Lake, CA; APN: 004-010-39.

PROJECT DESCRIPTION: Verification of compliance of the property with the General Plan designation of PF, Public Facilities, and RC, Resource Conservation. The project is evaluated for being in compliance with Lake County General Plan, the Upper Lake - Nice Area Plan, and the Lake County Zoning Ordinance, with the primary emphasis being placed on conformance with the General Plan.

ALL INTERESTED are invited to be present at the public hearing. All persons may provide public comment at the time and place indicated above. Due to the corona virus, the hearing may be a virtual hearing using Zoom.
