

## American Rescue Plan Act County Funding Proposal – Expanded Context for \$625,000 Request 9-3-2021

**Establish a Lake County Diaper Bank** – The opportunity exists to begin receiving free and/or steeply discounted shipments of diapers in Lake County if a diaper bank is established. Without a diaper bank, these opportunities are passing us by or are logistically challenging to take advantage of. First 5 Lake has been collaborating for over 18 months with local agencies and nonprofits to assess diaper need and come up with a streamlined system for storing and distribution in times of individual and community need. We've piloted this effectively during COVID-19 when large shipments of diapers and wipes were made available through First 5 California. We've gathered our local partners to participate in Zoom meetings with nonprofits in the region who are operating diaper banks in different ways, and we've learned from their efforts and our own pilot project.

<u>Help Me Grow Developmental Supports & Safety Net Navigation</u> – First 5 Lake has been working with local pediatricians and family practitioners, Easterseals Northern California, and Redwood Coast Regional Center for many years to improve efforts to increase access and awareness of regular developmental screenings and streamlined referral services for children ages 0-to-5 to catch developmental delays, social emotional disorders and disabilities early and provide support in boosting skills prior to kindergarten entry. What lacks in this effort is the investment into a county-wide data management system for care coordination to ensure no child falls through the cracks. COVID-19 resulted in families putting off well-child visits wherein developmental delays are most frequently caught early.<sup>i</sup>

Home Visiting & Child Development Services for New Parents - The home visiting program is intended to be a short-term investment specifically related to mitigating the impacts of COVID-19 on families with new babies and would be distributed to agencies/nonprofits who have existing home visitation programs to temporarily expand their capacity to take on greater caseloads with fewer eligibility restrictions during the pandemic and its aftermath, rather than starting a new home visitation program specifically for this purpose. A year-long investment in this work would be approximately \$75,000, with two years at roughly \$150K.

The request for funds for <u>child development services</u> in Clearlake is for the remaining \$400K-\$475K included in the proposal and is intended as an investment in the start-up costs involved in expanding birth-to-three wrap-around care services (similar to Early Head Start programing) in Clearlake. Local nonprofit partners are repeatedly turned down by the Federal Government for expansion of the Early Head Start program, but the need is undeniable and has increased due to the COVID-19 pandemic. The actual cost of sustaining the program once it launched would depend on a variety of factors and funding would need to come from other sources. The ARP funding could provide nearly half of the start-up costs.

We have examined the sources of funding available<sup>ii</sup> and determined that these requests do not overlap with other State or Federal sources of relief that are available.

If these or any other items in the proposal do not align with what the Board is prioritizing, the First 5 Lake Commission would welcome the opportunity to continue further dialogue about how it can be adapted to further coalesce with Vision 2028. To First 5 Lake, the act of designating 5% of County ARPA funds to early childhood recovery is more important than any one specific component of the proposal - that act would be a value statement to the Commission that indicates that we are making progress toward our own vision, "*One day the success of Lake County will be measured by the wellbeing of its youngest children*," and wisely investing in primary prevention for greatest return on investment.


