AMENDMENT TWO TO AGREEMENT FOR ABANDONED VEHICLE TOWING AND DISPOSAL SERVICES

by and between the County of Lake, hereinafter referred	to as '	'COUNTY"	and Kelseyv	ille Auto
Salvage and Towing, hereinafter referred to as "CONTRAC	CTOR".	1		

WITNESSETH

WHEREAS, COUNTY and CONTRACTOR have entered into an AGREEMENT dated August 18, 2020, to provide professional collection, transportation, storage, and disposal of abandoned and/or inoperative vehicles, part, or boats as part of the Lake County Abandoned Vehicle Abatement Program in the unincorporated area of Lake County; and

WHEREAS, that AGREEMENT was first amended on June 22, 2021 to extend the term of the AGREEMENT and to provide for the maximum yearly compensation over that newly-extended three-year term; and

WHEREAS, COUNTY and CONTRACTOR now desire to amend said AGREEMENT to allow for an increase to the annual compensation limits, for the second and third years of the AGREEMENT.

NOW, THEREFORE, the parties hereto agree as follows:

2. ARTICLE IV., "COMPENSATION", Paragraph 1 is hereby modified to read as follows:

COMPENSATION

CONTRACTOR has been selected by the COUNTY to provide services described in Section I of this Agreement for a term of three (3) fiscal years. The maximum amount of compensation to be paid in the first fiscal year for that period beginning on August 18, 2020 and ending on June 30, 2021 shall not exceed ten thousand dollars (\$10,000). The maximum amount of compensation to be paid in the second fiscal year for that period beginning on July 1, 2021 and ending on June 30, 2022 shall not exceed fifteen thousand five hundred dollars (\$15,500). The maximum amount of compensation to be paid in the third fiscal year for that period beginning on July 1, 2022 and ending on June 30, 2023 shall not exceed twenty thousand dollars (\$20,000). All compensation shall be based on written authorization prior to towing/abatement services and the Cost Proposal Attached as Exhibit B.

Except as specifically modified herein, all other terms and conditions of AGREEMENT dated August 18, 2020, and modified by the first amendment on June 22, 2021, shall remain in full force and effect.

COUNTY and CONTRACTOR has executed this Amendment to Agreement on the day and year first written above.
