

AMENDMENT NO. 1 TO THE AGREEMENT FOR PHYSICIAN CONSULTATION SERVICES  
CONTRACT TO PROVIDE PUBLIC HEALTH SERVICES BETWEEN THE COUNTY OF LAKE AND  
DR. GARY PACE

This Amendment No. 1 to Agreement is made and is entered into this 2<sup>nd</sup> day of August, 2022 by and between the COUNTY OF LAKE, a political subdivision of the State of California ("hereinafter referred to as "COUNTY") and Dr. Gary Pace ("hereinafter referred to as "CONTRACTOR").

WHEREAS, the Agreement for Physician Consultation Services was made and entered into the 22<sup>nd</sup> day of June, 2022; and

WHEREAS, the COUNTY appointed Dr. Gary Pace and ratified the Physician Consultation Services Agreement on June 28, 2022 to perform as Lake County's Public Health Officer; and

WHEREAS, the COUNTY continues to need the services of Dr. Gary Pace in the role of the Public Health Officer; and

WHEREAS, the CONTRACTOR has agreed continue in this role as Public Health Officer until August 31, 2022.

NOW, THEREFORE, the parties hereby agree as follows:

**A. Section 1 Term is hereby amended to read:**


The term of this Agreement shall commence on **August 2, 2022**, and will terminate **August 31, 2022**, unless renewed in writing prior to the termination date. Both parties can extend the agreement **monthly** with mutual written agreement.

The Parties agree that all other terms and conditions of the original Agreement shall remaining full force and effect.
