

**Amendment No. 1 to the AGREEMENT BETWEEN THE COUNTY OF LAKE AND
PARAGONS, LLC FOR CONSULTANT SERVICES TO THE LAKE COUNTY
CONTINUUM OF CARE ON BEHALF OF LAKE COUNTY BEHAVIORAL HEALTH
FOR FISCAL YEAR 2021-22**

This First Amendment to the Agreement is made and entered into by and between the County of Lake, hereinafter referred to as "County," and Paragons, LLC, hereinafter referred to as "Contractor," collectively referred to as the "parties."

RECITALS

WHEREAS, the parties hereto have entered into an Agreement dated July 1, 2021 under which Contractor will provide Specialty Mental Health Services to Lake County beneficiaries; and

WHEREAS, the parties now desire to amend the Agreement to increase the total compensation payable under the Agreement by \$5,723.00.00 for a new contract maximum of **Thirty Thousand Seven Hundred Twenty-Three Dollars (\$30,723.00).**

NOW, THEREFORE, the parties hereto agree to the following Amendment to the Agreement:

3. COMPENSATION. Contractor has been selected by County to provide the services described hereunder in **Exhibit A**, titled, **"Scope of Services."** **Compensation to Contractor shall not exceed Thirty Thousand Seven Hundred Twenty-Three Dollars (\$30,723.00).**

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
