LETTER OF CONDITIONAL AUTHORIZATION

(Calaveras Code §17.95.030.B)

THIS LETTER DOES NOT AUTHORIZE COMMERCIAL CANNABIS ACTIVITIES

NOTICE: Commercial cannabis activities remain prohibited on the premises controlled by the applicant identified in this letter until the applied-for commercial cannabis permit has been validated. A permit may be issued before it is validated, but it will only be validated after the Calaveras County Division of Cannabis Control has received a copy of the appropriate State license, verified that all permit eligibility criteria have been satisfied, and, if applicable, verified that permit conditions have been met (County Code §17.95.080).



The above named applicant has demonstrated baseline eligibility pursuant to §17.95.050.D except for subsections 8 and 9 and has undertaken steps to comply with Chapter 17.95 of the Calaveras County Code. The County will notify the appropriate state agency if the applicant is denied a permit after final vetting.

Business and Professions Code §26050.2

Local Authorization: This Letter of Conditional Authorization, unless later revoked, may be used as evidence that compliance with Calaveras County's commercial cannabis ordinance is underway for the purposes of satisfying the requirements of Business and Professions code §26050.2(a)(2).

CEQA Compliance: Business and Professions Code §26050.2(a)(1) requires that, if compliance with the California Environmental Quality Act is not complete, that it is underway before a provisional license may be issued. Upon issuance of this letter, the County has initiated the attached CEQA compliance checklist. The County's application process is not complete and no permit shall be validated until the applicant has demonstrated that all mitigation measures identified in the County's programmatic EIR, and required under Chapter 17.95 of the County Code, have been implemented and a compliance checklist has been completed. No commercial cannabis activities are authorized until the commercial cannabis permit has been validated by the Calaveras County Division of Cannabis Control.
