RESOLUTION AMENDING RESOLUTION NO. 2021-122 ESTABLISHING SALARIES AND BENEFITS FOR EMPLOYEES ASSIGNED TO THE CONFIDENTIAL UNIT, SECTION A, FOR OCTOBER 21, 2021 TO JUNE 30, 2025
