RESOLUTION AMENDING RESOLUTION NO. 2021-123 ESTABLISHING SALARIES AND BENEFITS FOR EMPLOYEES ASSIGNED TO THE CONFIDENTIAL UNIT, SECTION B, FOR OCTOBER 21, 2021 TO JUNE 30, 2025

WHEREAS, the Board of Supervisors of the County of Lake, State of California, has approved Resolution No. 2021-123 establishing salaries and benefits for Confidential B employees; and

WHEREAS, The Board now desires to henceforth declare June 19th as the Juneteenth holiday commemorating the final end to slavery in the United States and recognizes the anniversary of the announcement of General Order No. 3 by Union Army General Gordon Granger on June 19, 1865, proclaiming freedom for slaves in Texas.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lake, State of California, that Resolution No. 2021-123 is hereby amended as follows:

1. Effective 12/6/2022 Section 5 Leave Benefits, is hereby amended as follows:

5.8 Holidays

5.8.1 The following holidays shall be observed:

1. July 4 (Independence Day)

- 2. First Monday in September (Labor Day)
 - 3. Second Monday in October (Indigenous Peoples' Day)

4. November 11 (Veteran's Day)

5. Thanksgiving Day

6. Day after Thanksgiving Day

13	Assigned to the Confidential Unit, Section B, for October 21, 2021 to June 30, 2025 shall	
14	remain in full force and effect.
