4 **RESOLUTION AMENDING RESOLUTION NO. 2021-123 ESTABLISHING SALARIES**
5 **AND BENEFITS FOR EMPLOYEES ASSIGNED TO THE**
6 **CONFIDENTIAL UNIT, SECTION B, FOR OCTOBER 21, 2021 TO JUNE 30, 2025**

7 **WHEREAS**, the Board of Supervisors of the County of Lake, State of California, has
8 approved Resolution No. 2021-123 establishing salaries and benefits for Confidential B
9 employees; and

10 **WHEREAS**, the Board of Supervisors subsequently approved Resolution No. 2021-123
11 including the description of observed County holidays; and

12 **WHEREAS**, The Board now desires to henceforth declare June 19th as the Juneteenth
13 holiday commemorating the final end to slavery in the United States and recognizes the
14 anniversary of the announcement of General Order No. 3 by Union Army General Gordon
15 Granger on June 19, 1865, proclaiming freedom for slaves in Texas.

17 **NOW THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Lake,
18 State of California, that Resolution No. 2021-123 is hereby amended as follows:

- 19 1. Effective 12/6/2022 Section 5 Leave Benefits, is hereby amended as follows:

21 **5.8 Holidays**

22 5.8.1 The following holidays shall be observed:

- 23 1. July 4 (Independence Day)
24 2. First Monday in September (Labor Day)
25 3. Second Monday in October (Indigenous Peoples' Day)
26 4. November 11 (Veteran's Day)
27 5. Thanksgiving Day
28 6. Day after Thanksgiving Day

1 7. Winter Holiday (Monday – Friday of the week December 25th falls on, if December
2 25th falls on a weekday. If December 25th falls on a Saturday or Sunday, the 23rd
3 through the 29th of December.)

4 8. January 1 (New Year's Day)

5 9. Third Monday in January (Martin Luther King, Jr. Day)

6 10. Third Monday in February (President's Day)

7 11. Last Monday in May (Memorial Day)

8 12. June 19 (Juneteenth)

9 2. All prior amendments to Resolution No.2021-122 are hereby superseded with regard to
10 the description of observed County Holidays.

11 3. Except as specifically modified herein or by Resolution No. 2021-123, all terms and
12 conditions of Resolution No.2021-123 Establishing Salaries and Benefits for Employees
13 Assigned to the Confidential Unit, Section B, for October 21, 2021 to June 30, 2025 shall
14 remain in full force and effect.
