## THIRD AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF LAKE AND CRESTWOOD BEHAVIORAL HEALTH FOR ADULT RESIDENTIAL SUPPORT SERVICES AND SPECIALITY MENTAL HEALTH SERVICES FOR FISCAL YEAR 2015-16.

**THIS AMENDMENT** to the Agreement is made effective nunc pro tunc as of July 1, 2015, between the County of Lake, a political subdivision of the State of California (hereinafter referred to as "COUNTY"), and Crestwood Behavioral Health (hereinafter referred to as "CONTRACTOR").

WHEREAS, pursuant to said Agreement, a Lake County Medi-Cal beneficiary is placed at CONTRACTOR'S facility in Modesto; and

WHEREAS, this beneficiary's insurance was changed by Social Security in error; and

WHEREAS, the beneficiary's insurance change has been corrected; and

WHEREAS, Medi-Cal is denying the services billed by Crestwood and now the services are too old to bill even though the error has been corrected; and

WHEREAS, due to all of the above reasons, Lake County Behavioral Health (LCBH) is accepting responsibility to reimburse Crestwood for the unbillable daily IMD rate of \$192.10 per day in order to maintain the positive working relationship that LCBH currently has with Crestwood.

NOW, THEREFORE, based on the foregoing recitals, it is agreed as follows:

Additional Compensation: Notwithstanding COUNTY's reimbursement obligations under the article entitled COUNTY'S RESPONSIBILITIES in said Agreement, as amended, which obligations CONTRACTOR agrees have been fully satisfied, COUNTY agrees to pay CONTRACTOR additional compensation totaling \$29,392 (Twenty Nine Thousand Three Hundred Ninety Two Dollars) as remuneration for services rendered pursuant to said Agreement for which CONTRACTOR was not otherwise reimbursed from client's public or private resources, as delineated hereinabove. CONTRACTOR further agrees that said amount shall fully satisfy any and all amounts now owed or that may become owed by COUNTY to CONTRACTOR pursuant to that Agreement with COUNTY dated July 1, 2015.

**EXCEPT AS SPECIFICALLY MODIFIED HEREIN,** all other terms and conditions of the July 1<sup>st</sup>, 2015, Agreement and subsequent amendments shall remain in full force and effect.
