3 **RESOLUTION AMENDING RESOLUTION NO. 2016-178 PERTAINING TO TAX**
4 **REVENUE EXCHANGE FOR ANNEXATION TO COUNTY SERVICE AREA NO.2 –**
5 **SPRING VALLEY WATER SYSTEM (ANNEXATION – LAFCO PROJECT #2016-01)**
6 **TO CORRECT A TYPOGRAPHICAL ERROR**

7 **WHEREAS**, Section 99 of the Revenue and Taxation Code requires, before the LAFCO
8 Executive Officer issues a certification of filing for a proposed jurisdictional change, that
9 an exchange of property tax revenue be negotiated between the affected agencies; and

10 **WHEREAS**, a proposed jurisdictional change has been filed with the LAFCO Executive
11 Officer to annex certain properties to CSA #2 – Spring Valley Water System, the
12 LAFCO short form designation for such proposal is LAFCO Project #2016-01
13 Annexation; and

14 **WHEREAS**, Resolution No. 2016-178 contains a typographical error in that the LAFCO
15 project number is incorrect, which will be corrected by this Resolution.

16 **NOW, THEREFORE, BE IT RESOLVED** that:

- 17 1. Upon finalization of the LAFCO Project #2016-01 Annexation, property tax
18 revenues generated from within the annexed area shall be allocated as follows:

19 Base Property Tax: The base property tax revenue currently allocated to the
20 County General Fund and all local taxing entities shall not be changed as a result
21 of this annexation.

22 Future Property Tax: The future property tax increment allocated to the County
23 General Fund and all local taxing entities shall not be changed as a result of this
24 annexation.

- 25 2. The Clerk of the Board is directed to file a certified copy of this resolution with the
26 State Board of Equalization, the Auditor-Controller of the County of Lake and the
27 LAFCO Executive Officer.
