4 AMENDMENT NUMBER THREE AMENDING RESOLUTION NO. 2015-135 ESTABLISHING
5 SALARIES AND BENEFITS FOR MANAGEMENT EMPLOYEES FOR THE PERIOD FROM JULY 1,
6 2015 TO DECEMBER 31, 2016

8 WHEREAS, the Board of Supervisors has approved Resolution No. 2015-135
9 establishing salaries and benefits for management employees; and
10

11 WHEREAS, Section 1.2.2 of said resolution provides Longevity Steps for Elected
12 Department Heads; and
13

14 WHEREAS, the Board of Supervisors has determined said provision may not be
15 clear about the Board's original intent to compound such longevity steps; and
16

17 WHEREAS, the County's Elected Official Action H.R./Payroll Processing Form has
18 accurately stated the compounding as originally intended, and
19

20 WHEREAS, the Board of Supervisors has determined that the Resolution should be
21 amended to clarify the original intent;

23 NOW, THEREFORE, BE IT RESOLVED THAT effective _____,
24 Section 1.2.2 is amended as follows:
25

26 1.2.2 Longevity Steps for Elected Department Heads

27 In addition to the base salary, incumbents in the offices of Assessor-Recorder,
28 Auditor-Controller, District Attorney, Sheriff-Coroner and Treasurer-Tax Collector may
29

be eligible for the additional compounded steps (for salaries as shown on Attachment A-0) based on the cumulative years of service with the County of Lake. The specified years of service must be met prior to taking office and at least two years must be served immediately prior to assuming elected office:

<u>Longevity Step</u>	<u>Cumulative Years of Services</u>	<u>Compounded</u>
1	5 years	2.5%
2	10 years	5.062%
3	15 years	7.689%

Except as specifically modified herein and in prior amendments, all other terms and conditions of Resolution No. 2015-135 Establishing Salaries and Benefits for Management Employees for the period from July 1, 2015 to December 31, 2016 shall remain in full force and effect.
