RESOLUTION APPROVING THE ELECTION DATE CHANGE

RESOLVED by the Board of Supervisors of the County of Lake, State of California, that it finds, determines and hereby declares THAT:

WHEREAS, California Elections Code §10404.5 authorizes a governing board of a county board of education to adopt and submit a resolution requesting that the county board of education's governing board member election be consolidated with the statewide election to the Board of Supervisors no later than 240 days prior to the county board of education's current scheduled governing board member election in November, 2017; and,

WHEREAS, the Lake County Board of Education Board of Trustees has adopted a resolution requesting that the Lake County Board of Supervisors consider changing Lake County Board of Education's Governing Board Member Elections from odd-numbered years to even-numbered years; and,

WHEREAS, the Lake County Board of Education's Resolution was submitted and accepted by the Board of Supervisors at their regular meeting on March 7, 2017; and,

WHEREAS, the Registrar of Voters has determined that the change of election date will not cause the ballot layout, computer capacity or voter equipment to be exceeded with the consolidation of the Lake County Board of Education's Governing Board Member Elections; and,

NOW THEREFORE, BE IT RESOLVED pursuant to Section 10404.5 of the Elections Code, State of California, the Lake County Board of Supervisors approves Lake County Board of Education Board of Trustee's request to change the Lake County Board of Education's Governing Board Member Elections from odd-numbered years to even-numbered years and authorizes the Lake County Registrar of Voters to move the Lake County Board of Education's odd-year election and consolidate the County Board of Education's Elections with the Statewide General Election commencing with the November 6, 2018 General Election and those Governing Board Members on the Board of Trustees whose terms would have expired in 2017 and 2019 shall continue in their offices for an additional year.
