10        **WHEREAS**, Section 99 of the Revenue and Taxation Code requires, before the  
11        LAFCO Executive Officer issues a certification of filing for a proposed  
12        jurisdictional change, that an exchange of property tax revenue be negotiated  
13        between the affected agencies; and

15        **WHEREAS**, a proposed jurisdictional change has been filed with the LAFCO  
16        Executive Officer to annex a certain property to Finley County Water District, and  
17        the LAFCO short form designation for such proposal is LAFCO Project #2016-04  
18        Annexation.

20        **NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the  
21        County of Lake, State of California, that:

- 23        1. Upon finalization of the LAFCO Project #2016-04 Annexation, property tax  
24        revenues generated from within the annexed area shall be allocated as  
25        follows:

27                Base Property Tax: The base property tax revenue currently allocated to the  
28                County General Fund and all local taxing entities shall not be changed as a  
29                result of this annexation.  
30

31                Future Property Tax: The future property tax increment allocated to the  
32                County General Fund and all local taxing entities shall not be changed as a  
33                result of this annexation.

- 35        2. The Clerk of the Board is directed to file a certified copy of this resolution with  
36        the State Board of Equalization, the Auditor-Controller of the County of Lake  
37        and the LAFCO Executive Officer.
