SUMMARY

On June 19, 2017, Community Development staff received a Nuisance Abatement Hearing Request Form from the property owner representative Marc Valdivia; see Attachment 1. The Hearing Request form listed the reasons why Mr. Valdivia believes the property should not be considered a public nuisance. The Hearing Request was received due to a Notice of Nuisance and Order to Abate; see Attachment 2, being issued and a copy sent certified mail to the property owner of record.

On May 31, 2017, Code Enforcement staff conducted a site visit at the property located at; **3260 Klein Street, Nice CA**. Upon arriving at the property, property owner Valdivia was present at the site. Contact was made with her and she was informed by Code Enforcement Officer Michael Penhall that it was against County ordinance to camp, to have any open and outdoor storage and a shed without a primary residence on a vacant parcel. After speaking with Ms. Valdivia, a Notice of Nuisance and Order to Abate was prepared and a copy provided to her there at the property.

This referenced property is .087 acres, zoned "RR" with **NO** permitted primary residence. As of this date, per Community Development Department records, there have are no permits applied for or obtained for this property; *see Attachment 3*. The Lake County Zoning Ordinance; Chapter 21, Section 2.6; Chapter 21, Section 3.8 (a); Chapter 21, Section 41.12 and California Health and Safety Code; Section 17920.3 does not allow for camping and open and outdoor storage on a vacant parcel.

RECOMMENDATION

Code Enforcement Staff recommends that the Board uphold the Notice of Nuisance and Order to Abate dated May 31, 2017 and authorize staff to move forward with the abatement process and remove and dispose of any/all open and outdoor storage located on aforementioned property.

PURSUANT TO CHAPTER 13 OF THE LAKE COUNTY CODE, SECTION 13-7, YOU ARE HEREBY NOTIFIED THAT IF YOU WISH TO SHOW ANY CAUSE WHY SUCH CONDITION SHOULD NOT BE ABATED AS A PUBLIC NUISANCE BY THE ENFORCEMENT OFFICIAL, YOU MUST REQUEST A PUBLIC HEARING BEFORE THE LAKE COUNTY BOARD OF SUPERVISORS BY COMPLETING A NUISANCE ABATEMENT HEARING REQUEST FORM. SAID FORM IS AVAILABLE AT THE COMMUNITY DEVELOPMENT DEPARTMENT (LOCATED AT 255 N. FORBES STREET, LAKEPORT) AND MUST BE FILED WITHIN 21 DAYS OF SERVICE OF THE NOTICE OF NUISANCE AND ORDER TO ABATE. IF YOU FAIL TO REQUEST A NUISANCE ABATEMENT HEARING, ALL RIGHTS TO APPEAL ANY ACTION OF THE COUNTY TO ABATE THE NUISANCE WILL BE WAIVED.
- E. PURSUANT TO CHAPTER 13 OF THE LAKE COUNTY CODE, IF YOU FAIL TO CORRECT THE NUISANCE CONDITIONS BY THE DATE SPECIFIED IN SECTION C OF THIS NOTICE AND ORDER OR ANY SUBSEQUENT TIME EXTENSION GRANTED BY THE ENFORCEMENT OFFICIAL, AND/OR FAIL TO SUCCESSFULLY SHOW CAUSE WHY SUCH CONDITION SHOULD NOT BE ABATED AS SPECIFIED IN SECTION D OF THIS NOTICE, THE ENFORCEMENT OFFICIAL MAY RECORD THIS NOTICE AND ORDER AND MAY ABATE THE PUBLIC NUISANCE. THE COSTS OF SAID ABATEMENT WILL BE RECOVERED BY ONE OR MORE OF THE FOLLOWING MEANS:
 - 1) A CHARGE AGAINST THE PREMISES WITH THOSE COSTS MADE A SPECIAL ASSESSMENT AGAINST THE PREMISES. SAID SPECIAL ASSESSMENT MAY BE COLLECTED AT THE SAME TIME AND IN THE SAME MANNER AS IS PROVIDED FOR THE COLLECTION OF ORDINARY COUNTY TAXES, AND SHALL BE SUBJECT TO THE SAME PENALTIES, INTEREST AND TO THE SAME PROCEDURES OF FORECLOSURE AND SALE IN THE CASE OF DELINQUENCY AS IS PROVIDED FOR ORDINARY COUNTY TAXES.
 - 2) PAID THROUGH A CODE ENFORCEMENT DEBT REDUCTION AGREEMENT THAT HAS BEEN NEGOTIATED WITH THE LAKE COUNTY TREASURER TAX COLLECTOR.
 - 3) REFERRED TO A DEBT COLLECTION AGENCY LICENSED BY THE STATE OF CALIFORNIA IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 26220(a).
