BOARD OF SUPERVISORS, COUNTY OF LAKE, STATE OF CALIFORNIA ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 2-192.1 OF ARTICLE XXVI, CHAPTER 2 OF THE LAKE COUNTY CODE, PROVIDING AUTHORITY TO EXECUTE LEASES AND LICENSES

WHEREAS, Lake County Code section 2-192.1, as previously codified, authorized the County Administrative Officer to execute leases and licenses let pursuant to Section 2-191 and upon approval by the Board of Supervisors under Section 2-190, which authority expired on December 31, 2015; and

WHEREAS, the effect of this section has been to provide a more transparent process for those leasing or licensing County property, without any detriment to the County

NOW, THEREFORE, the Board of Supervisors of the County of Lake ordains as follows:

Section 1:

The Board of Supervisors of the County of Lake hereby amends section 2-192.1 of Article XXVI, Chapter 2 of the Lake County Code to read as follows:

192.1 The County Administrative Officer, or his/her designee is authorized to execute leases and licenses let pursuant to Section 2-191 and upon approval by the Board of Supervisors under Section 2-190. Such authority shall expire on July 1, 2022.

Section 2:

All ordinances or parts of ordinances or resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict and no further.

Section 3:

This ordinance shall take effect on thirty (30) days after its passage. Before the expiration of fifteen (15) days after passage of this ordinance, it shall be published at least once with the names of the members of the Board of Supervisors voting for an against the ordinance in a newspaper of general circulation published in the County of Lake, State of California.
