REIMBURSEMENT OF COSTS ASSOCIATED WITH REMOVAL OF VALLEY FIRE STRUCTURAL
AND TREE DEBRIS FROM PRIVATE PROPERTY

WHEREAS, in the fall of 2015, property owners authorized the County and/or its designee to enter private property, and remove Valley Fire structural and tree debris that presented a health and safety hazard to the general public; and

WHEREAS, at that time, property owners acknowledged responsibility for and agreed to reimburse the cost of debris removal, to the extent covered under their insurance policy; and

WHEREAS, significant time passed between the signage of these initial agreements and the provision of all materials necessary for collection of reimbursement payments; and

WHEREAS, some property owners have settled claims with their insurance companies, but, for various reasons, did not hold back the amounts they were paid for debris removal; and

WHEREAS, those property owners who did not hold back amounts paid for debris removal require the option to make payments over a reasonable period of time; and

WHEREAS, the number of property owners needing to make payments could be sizeable and it would not be efficient to come to the Board for approval of each and every agreement.

NOW, THEREFORE, the Board of Supervisors of the County of Lake resolves as follows:

 Carol J. Huchingson, County Administrative Officer (CAO), is hereby authorized to execute reimbursement agreements and related documents for collection of debris insurance proceeds up to the amount allowed by each property owner's available insurance coverage.
