4 **RESOLUTION FIXING TAX RATES FOR LOCAL AGENCIES, GENERAL OBLIGATION BONDS**
5 **AND OTHER VOTER APPROVED INDEBTEDNESS FOR FISCAL YEAR 17/18**

7 **WHEREAS**, Section 29100 of the California Government Code requires that on or before
8 October 3 of each year, the board shall adopt by resolution the rates of taxes on the secured roll, not
to exceed the one-percent limitation specified in Article XIII A of the Constitution and Sections 93 and
100 of the Revenue and Taxation Code; and

9 **WHEREAS**, the amounts needed to make annual payments for the interest and principal
10 on general obligation bonds and other indebtedness approved by the voters and as authorized by
law, has been determined.

11 **NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS THAT:**

12 Within the County of Lake the ad valorem rates of taxation to be levied and to be collected
13 on each One Hundred Dollars (\$100.00) of assessed valuation of the property in the County of Lake
for fiscal year 2017/2018 are fixed as follows:
