A RESOLUTION TEMPORARILY PROHIBITING PARKING AND  
AUTHORIZING REMOVAL OF VEHICLES AND  
ORDERING THE DEPARTMENT OF PUBLIC WORKS TO POST SIGNS

WHEREAS, Hidden Valley Lake Association, will be holding its Annual Community Easter Egg Hunt on the grounds of the Hidden Valley Lake Campground, located on Hartmann Road on March 24, 2018, in Hidden Valley, from 9:00 a.m. to 11:30 a.m.; and

WHEREAS, parking at the event is limited and off-site parking is required; and

WHEREAS, the Hidden Valley Lake Association has stated that past events have drawn an over abundance of attendees that park in the county right of way, thereby requiring attendees to walk in the roadway in order to get from their vehicles to the event; and

WHEREAS, the Hidden Valley Lake Association has requested that no parking be allowed on Hartmann Road during the event so that attendees have sufficient room to safely walk along side the roadway from designated parking areas to the event without having to walk in the roadway; and

WHEREAS, Section 22651, subdivision (n) of the Vehicle Code, authorizes this Board to prohibit parking and remove of vehicles where signs are posted giving notice of the removal; and

WHEREAS, it is in the public's best interest to temporarily prohibit parking on Hartmann Road during this event.

NOW, THEREFORE, the Board of Supervisors of the County of Lake does hereby find, determine, resolve and order as follows:

1. No person shall park any vehicle in the following location from 9:00 a.m. through 11:30 a.m. on March 24, 2018:

(a) On either side of Hartmann Road, County Road No. 104, from Hidden Valley Road, a non-county maintained road, to Bowcher Lane, County Road No. 104D.

2. All vehicles parked in violation of this Resolution may be removed as provided by law.
3. The Hidden Valley Lake Homeowners Association shall post signs giving notice of the removal as provided in Section 22651, subdivision (n), of the Vehicle Code.
