APPROVE RESOLUTION AMENDING RESOLUTION NO. 2017-124 TO AMEND THE ADOPTED BUDGET FOR FY 2017-18 BY APPROPRIATING UNANTICIPATED REVENUE IN THE AMOUNT OF \$100,000 FOR BUDGET UNIT 4010 - ENVIRONMENTAL HEALTH SERVICES IN SUPPORT OF THE CERTIFIED UNIFIED PROGRAM AGENCY (CUPA)

WHEREAS, Government Code Section 29130 provides that unanticipated revenue may be made available for specific appropriation by a four-fifths vote of the Board at any regularly scheduled or properly noticed special meeting;

WHEREAS, it is necessary to appropriate said revenue into the Lake County Department of Health Services Budget in order to use the funds.
