

**Amendment No. 2 TO THE AGREEMENT BETWEEN THE COUNTY OF LAKE AND  
KINGS VIEW CORPORATION FOR PROFESSIONAL CONSULTING SERVICES  
FOR FISCAL YEAR 2017-18**

This Amendment No 2 to Agreement is made and entered into this 3rd day of April, 2018 by and between the County of Lake, a political subdivision of the State of California (hereinafter referred to as "County") and Kings View Corporation (hereinafter referred to as "Contractor").

**RECITALS**

**WHEREAS**, the parties hereto have entered into an Agreement dated July 1, 2017 under which Contractor will provide professional fiscal consulting services for Lake County; and

**WHEREAS**, the parties first amended the Agreement on or about October 23, 2017 in order to increase the maximum payable under the Agreement and to expand on the services listed in Exhibit A, Section 4-Description of Services; and

**WHEREAS**, the parties now desire to amend the Agreement a second time in order to further increase the maximum payable under the Agreement and to further expand on the services listed in Exhibit A-Section 4-Description of Services;

**NOW, THEREFORE**, the parties hereby agree as follows:

**1. Section 3 – COMPENSATION is hereby amended to read:**

"Contractor has been selected by County to provide the services described hereunder in **Exhibit "A" entitled "Scope of Services"**, attached hereto. Compensation to Contractor shall not exceed **Forty Four Thousand Six Hundred Thirty Five Dollars (\$44,635)**.

**Exhibit A, Section 4 –Description of Services** is hereby amended to read as follows:

**"4. DESCRIPTION OF SERVICES** Contractor will provide electronic health record support, Cost Report support, and training for the Substance Use Disorder (SUD) Cost Report.

Contractor shall also provide additional electronic health record training as follows:

- Staff Setup – 4 hours
- Scheduler Setup – 2 hours
- Service Code Setup – 4 hours
- Unit/Subunit and Assignment/Treatment Session Setup – 8 hours
- Security and Global Settings – 16 hours
- Treatment Plan and Progress Note Setup - 8 hours
- Clinician's/Doctor's Homepage – 8 hours
- Action Schedules – 4 hours
- Document Management and Signature Pad Setup – 1 hour
- Diagnosis Code and Demographic Setup – 4 hours

- WYSIWYG – 12 hours
- Utilities – 8 hours
- Promotion Review /Cerner Support Tickets – 1 hour”

Contractor shall also provide additional health record support by progressing the Electronic Health Record to the latest promotion which will include progress note rewrite.”

The Parties agree that all other terms and conditions of the original Agreement shall remain in full force and effect.
