3 RESOLUTION EXPRESSING THE INTENT OF THE BOARD OF SUPERVISORS  
4 IN PROHIBITING A CANNABIS CULTIVATION SITE WITHIN 1000 FEET OF A  
5 WATER SPHERE OF INFLUENCE IN LAKE COUNTY ORDINANCE NO. 3073

6 RECITALS

7 WHEREAS, Article 72 of the Lake County Zoning Ordinance, as amended by Ordinance  
8 No. 3073, presently provides the no cannabis cultivation site may be located within 1000 feet of  
9 an existing water sphere of influence; and

10 WHEREAS, it has come to the attention of the Board of Supervisors that the language  
11 used in that prohibition has been subject to an interpretation in apparent conflict with the intent of  
12 this Board as it relates to the proximity of a cultivation site to a water service sphere of influence;  
13 and

14 WHEREAS, the Board of Supervisors desires that staff amend the language of Ordinance  
15 3073 to further clarify the Board's intention in implementing said prohibition; and

16 WHEREAS, the Board of Supervisors desires that its intent and interpretation of said  
17 prohibition be implemented while said amendment is being advanced.

18 NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 19 1. The foregoing recitals are true and correct.
- 20 2. In adopting the prohibition in Ordinance No. 3073 requiring that no cultivation site be  
21 located within 1000 feet of a water service sphere of influence, it was not the intention of  
22 this Board that such prohibition be unilaterally applied to a water service that is not subject  
23 to tie-in/access to service. This Board acknowledges and agrees that if such a cultivation  
24 site located within 1000 feet of a water service sphere of influence does, at any future time,  
25 become eligible for tie-in or becomes entitled to other means of access to said service, said  
26 prohibition shall be applicable.
