11	WHEREAS, all parties wish to continue their participation through at least June 30, 2019; and		
12	WHEREAS , completion of a new Agreement is not feasible prior to expiration of the current Agreement.		
13	NOW, THEREFORE, the parties hereto agree as follows:		
14	1. That Section 7. of the original agreement is hereby amended as follows:		
15	This Agreement shall begin on the date of execution by all parties to this Agreement and shall		
16	continue in full force and effect until June 30, 2019 unless terminated as hereinafter provided.		
17	By March 1, 2019, the City Managers of each City and the County Administrative Officer shall		
18	meet to discuss the extension of this Agreement.		
19	Except as specifically modified herein, all other terms and conditions of the November 17, 2015		
20	Agreement shall remain in full force and effect.
