Resolution Establishing 2018-2019 Appropriations Limit  
for the County of Lake and Special Districts Governed by the Board of Supervisors

WHEREAS, Article XIII B of the California State Constitution restricts government spending of Proceeds of Tax Revenue by establishing limits on the annual Appropriations of Local Agencies, and;

WHEREAS, Section 7910 of the Government Code requires the Governing Body of each local jurisdiction to establish an appropriations limit each year by Resolution, and;

WHEREAS, the appropriations limit has been computed using the change in population for the County of Lake and the change in California per capita personal income as delineated by the California Department of Finance in May 2018, and;

WHEREAS, the limit factor calculation for 2018-2019 is 1.0422, and;

WHEREAS, documentation used in determining the appropriations limit and all calculations have been available for public review at least fifteen (15) days prior to the approval of the limit by the Governing Body,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lake that:

Pursuant to Article XIII B of the State Constitution the 2018-2019 appropriations limit for the County of Lake and Special Districts governed by the Board of Supervisors is as follows:
