

SECOND AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF LAKE
AND CALSERVE INC., FOR PROFESSIONAL PROCESS SERVICES

This amendment to Agreement is made this ___ day of June, 2018 by and between the County of Lake (hereinafter referred to as "County") and Calserve, Inc.(hereinafter referred to as "Contractor").

Whereas, the County entered into an agreement with Contractor effective July 1, 2016 and a termination date of June 30, 2017, for service of process, with a First Amendment extending those services to June 30, 2018;

Whereas, the parties desire to amend this agreement a second time to extend the agreement to an additional year.

NOW, THEREFORE, the parties hereto agree as follows:

II. COUTNY'S RESPONSIBILITIES

"DCSS shall compensate Contractor for services, in accordance with Exhibit "A", attached hereto and incorporated herein, The total maximum allowed under this contract shall be \$25,000."

III. TERM

"This Agreement shall commence on July 1, 2018 and shall terminate on June 30, 2019."

Except as specifically modified herein, all other terms and conditions of the July 1, 2016 Agreement shall remain in full force and effect.
