RESOLUTION AUTHORIZING THE ASSESSOR TO APPLY FOR THE STATE SUPPLEMENTATION FOR COUNTY ASSESSORS' PROGRAM

- WHEREAS, the State Legislature has determined that State and local governments benefit when County Assessors are able to fairly, accurately and expeditiously assess property for property tax purposes; and
- WHEREAS, for the fiscal year 2018-19 through fiscal year 2020-21, inclusive, the State has created the State Supplementation for County Assessors' Program to provide matching funds for that effort; and
- **WHEREAS,** State Supplementation Funds shall be used to supplement, and not supplant, existing funding and staffing levels; and
- **WHEREAS,** participation in the State Supplementation for County Assessors' will provide much needed additional resources to the Office of the Assessor; and
- WHEREAS, the County of Lake Assessor is interested in participating in fiscal year 2018-19 to fund the scanning, verification and inputting of core property information to provide efficiencies in the process of property tax values and
- WHEREAS, the County is required to provide matching funds at the rate of one dollar for every two dollars requested from the State, which will be \$30,000 for the County contribution and \$60,000 from the State; and
- WHEREAS, the fiscal year 2018-19 Budget presently includes \$30,000 in matching funds and no additional General Fund contribution is requested; and
- **WHEREAS**, the application for the State Supplementation for County Assessors' Program is due on September 1, 2018; and
- **WHEREAS**, a Resolution from the County of Lake Board of Supervisors is required along with the application to be considered for the additional funds; and
- NOW, THEREFORE, BE IT RESOLVED that the County of Lake Board of Supervisors hereby approves \$30,000 in matching funds included in the Budget and authorizes the Assessor to submit an application to participate in the State Supplementation for County Assessors' Program and sign any related documents.
