2. Represented Southern California on the Governor's Committee to develop Senate Bill 1841, Standardize Incident Management System which resulted in S.I.M.S.
3. Elected by the Sothern California Counties and Cities to serve as the Chairman of the Southern California Disaster Advisory Committee to the Governor.
4. Represented the County of Riverside on the Southern California Earthquake Preparedness Project, S.C.E.P.P.
5. Director on the Inland Business Council for Emergency Preparedness.
6. Riverside and Monterey County Arson Task Force.

Briefly why I want to serve and what special qualifications or expertise I have.

1. I have 35 years in the fire service and I believe in offering my commitment to serve the Lakeport Fire District Staff and the citizens the district protects.
2. Before I retired on January 3, 2000, I had the Northwest Division of the Riverside Cal Fire Unit. The county along with 15 cities had a contract for fire protection and disaster management.
3. NORTHWEST DIVISON: Consisted of the Norco Inmate Conservation Camp, the Jurupa Battalion (5 Fire Stations), the Corona Battalion (5 Fire Stations), and one Community Service Fire Contract.
4. Type of Incidents: All types of fires, floods, earthquakes, wind storms, and medical aids.

5. Worked on County and City contract budgets and developed a 12 year replacement mobile fire equipment budget. Supervised both full time firefighters and volunteer firefighters.
6. The camp responded with inmate crews to wildland fires, floods, and other emergencies. One inmate crew operated a camp kitchen for feeding fire crews on large fire.

EMERGENCY SERVICES DIVISION:

1. Managed Riverside County Disaster Management Program working with FEMA, Cal OES, and R.A.C.E.S. over 500 Rodeo Amateur Civil Emergency Services volunteers. Administered 15 City Disaster Management Contracts to meet FEMA and OES standard and worked on affordable budgets for service.
2. Worked to increase the disaster budget to increase the staff from 4 to 8.
3. Developed the E.B.S. Emergency Broadcast System for Riverside County.

1. Lakeport Police Department: Volunteer Sergeant. As a former peace officer with Cal Fire and disaster planning, I enjoy giving back to serve. (8 years).
