This proposal is a fixed bid proposal for WW California to upgrade an existing InTouch version 7X to 2017 for Lake County Sanitation. The existing Lake County system consists of four (4) stand-alone 'thick client' InTouch workstations. These four (4) workstations will be replaced with new hardware that will run the newly upgrade applications. In addition to the upgrade, optionally we have included service pricing for the installation and configuration of a new Historian with up to 500 tags and TopView alarm annunciation with up to 150 alarms.

General Project Notes & Scope include:

- 1. Three (3) days onsite to install, test and commission the upgraded InTouch Application
- 2. InTouch application will not be modernized as part of this upgrade
- 3. Reporting such as Excel is not included in this proposal
- 4. Historian configuration and .LGH file migration of past 3 years
- 5. TopView implementation (With up to 3-5 unique schedules)
- 6. TopView unique configuration documentation

Assumptions:

- 1. New PC hardware will be provided by WWCal or others, including required Operating System (OS) software.
- 2. All Wonderware licensing will be provided by WWCal or others.
- 3. Customer would be responsible for physical installation and wiring of all project-related hardware
- 4. TopView modem not included.
