*A Proclamation Posthumously Recognizing Deputy Sheriff Robert Rumpfelt
for his Dedication, Service, and his Ultimate Sacrifice*

- WHEREAS,** Deputy Sheriff Robert Rumpfelt was born in Napa, California, on December 7, 1966, as the first of three children born to Robert and Juanita Rumpfelt; and
- WHEREAS,** Robert Rumpfelt was raised in Lake County, where he attended local schools, ultimately graduating in 1985 from Clear Lake High in Lakeport; and
- WHEREAS,** Robert Rumpfelt, immediately upon graduation answered the call to serve his country by enlisting in the United States Marine Corps where he learned honor, courage, and commitment; traits which he carried throughout his life; and
- WHEREAS,** Robert Rumpfelt, while enlisted as a United States Marine, was awarded the Sea Service Deployment Ribbon, the Overseas Service Ribbon, the Good Conduct Medal, the Navy Unit Commendation Medal, the National Defense Ribbon, the Southwest Asia Service Medal, the Kuwait Liberation Medal, and the Rifle Sharpshooter Badge during his enlistment; and
- WHEREAS,** Robert Rumpfelt put himself through the Napa Valley Junior College Police Academy, graduated from the academy in 1994, and continued his education earning a Bachelor of Arts Degree in Criminal Justice Management from Union Institute and University in 2004; and
- WHEREAS,** Robert Rumpfelt dedicated countless hours to mentoring troubled youth, and coaching the Clear Lake High School football team where he had a lasting impact on the character, development, and maturity of dozens of athletes, and the countless youth; and
- WHEREAS,** Robert Rumpfelt, was hired as a Deputy Sheriff for the Lake County Sheriff's Office in 2014, and served as a patrol deputy, firearms instructor, field training officer, and Gang Task Force member; and
- WHEREAS,** Deputy Sheriff Robert Rumpfelt, on August 22, 2017 completed his end of watch with honor, earning the highest respect possible.

NOW, THEREFORE, BE IT PROCLAIMED that the Board of Supervisors, County of Lake, California does hereby recognize that Deputy Sheriff Robert Rumpfelt has paid the ultimate sacrifice to defend those that love him most, his family and friends, community and county.
