Second Amended Second Agreement for Residence Emergency Disaster

Assistance

Member County: Lake

Purpose:

- Golden State Finance Authority ("GSFA") is a joint powers authority comprised of member and associate member counties and cities, which provides affordable housing and energy efficiency programs
- Since 2015 the County of Lake has experienced repeated and unprecedented wildfires that devastated the County, burning more than 50% of the land, causing tremendous loss of housing, and creating housing instability.
- Lake County is a member of GSFA.
- Due to the tremendous loss of homes and the housing instability that resulted from the catastrophic wildfires since 2015, GSFA has provided grant funding for the purpose of assisting Lake County residents who lost their homes or have experienced financial loss, or fire-related expense, in the State and/or federally declared disaster area.
- Through this agreement, GSFA has provided a total of \$1,050,000 ("Grant Funds") to the County of Lake for financial assistance toward obtaining, maintaining, or reestablishing temporary or permanent housing for individuals and families within Lake County whose ability to obtain, maintain, or restore housing has been impaired by a state or federally declared fire disaster since January 1, 2015.
- The Grant Funds shall be allocated in accordance with the provisions of this Agreement.
- The parties acknowledge and agree that these funds have been fully disbursed by GSFA to the County of Lake prior to execution of this Second Amended Second Agreement for Residence Emergency Disaster Assistance.

Payments and Terms:

GSFA has providing a total of One Million and Fifty Thousand Dollars (\$1,050,000) to Lake County for wildfire-related housing assistance in two grants. This second agreement is for \$700,000 to be used solely for the purposes set forth below under "Expenditures." The funds must be expended or returned to GSFA by December 31, 2019. Funds that are unexpended at the end of the term must be reimbursed by check to GSFA within 45 days of the end term date. Expenditures:

- The grant funds must be used to further efforts to provide safe and sanitary stable housing to individuals and/or families resident in Lake County meeting either of the following criteria:
 - 1. Displaced by a state or federally declared fire disaster since January 1, 2015 due to destroyed or damaged residences located within the applicable fire disaster area:
 - The destroyed or damaged residence must have been primary residence of the beneficiaries immediately prior to the disaster (owner-occupied or rental);
 - The damage has not permitted occupant(s) to return to the residence for at least 30 days;

Or

- 2. Suffered loss of income or similar financial loss or fire-related expense that impairs their ability to obtain or maintain housing as a direct result of a state or federally declared fire disaster since January 1, 2015.
- Assistance to an individual household will be limited to a maximum amount of twentyfive hundred dollars (\$2,500) per state or federally declared fire disaster.
- Interim rental assistance may include housing costs, such as assistance with utility bills or home utility reconstruction repairs.

- The grant funds may be provided to organizations that assist individuals and families meeting the above criteria.
- The grant funds may not be used for activities unrelated to providing safe and sanitary housing for individuals and/or families meeting the above criteria.
- Fees charged to administer the program by the county or a third-party administrator shall not exceed five percent (5%) of the allocated funds.
- These funds are to be used to supplement and not supplant funds received from the Federal Emergency Management Agency and/or the State Office of Emergency Services.

Audit, Accounting, and Records Retention:

Lake County is responsible and accountable for ensuring that expenditures are appropriate and that proper internal supporting documentation is maintained to provide clear separate tracking of the GSFA funds in accordance with Generally Accepted Accounting Principles. The GSFA funds are subject to audit by GSFA-designated representative(s). Supporting documentation shall be retained at the County in a single file to facilitate review and retention. GSFA representative(s) shall have the right to review and copy any records and supporting documentation pertaining to the use of the GSFA funds and shall have the right to interview staff relevant to the audit/review. Lake County shall retain all records for three (3) years after the end term date.

<u>Reporting:</u> Within 45 days of the end term date, the County shall provide GSFA with a general report regarding the use of the funds and the assistance provided. A detailed accounting of the use of the funds is not required as a part of this report, but Lake County shall provide additional supporting documentation upon request by GSFA.

Indemnity:

Lake County agrees to indemnify, defend and save harmless GSFA and its officers, agents, and employees from any and all claims and/or losses accruing or resulting from the performance of any work performed or services provided through the use of the GSFA funds.

Compliance:

Lake County agrees to comply fully with all applicable federal, state, and local laws, ordinances, regulations, and permits and with the terms provided regarding the use of the grant funds.

Termination:

GSFA may terminate this Agreement by giving sixty (60) days written notice for violation of any provision of this Agreement where such violation is not cured within sixty (60) days after written notice by GSFA or, where such violation cannot reasonably be cured within

sixty (60) days, Lake County fails to promptly begin such cure and thereafter bring it to completion in a reasonably expeditious fashion.

Entire Agreement:

This Second Amended Second Agreement for Residence Emergency Disaster Assistance replaces and supersedes that certain Amended Second Agreement for Residence Emergency Disaster Assistance Program between the parties hereto dated January 16, 2018 and constitutes the entire understanding between the parties hereto. No changes, amendments or alterations shall be effective unless in writing and signed by both parties.
